- c.Studying the agenda of the boards and committees meetings in which the Secretary-General participates, preparing summaries of discussion topics, and proposing appropriate recommendations.

- d.Preparing for the Secretary-General's interviews with various audio, visual and printed media.
- e. Preparing the speeches and addresses for official events in which the Secretary-General participates whether inside or outside the country.
- 3. Administrative Affairs Division, which shall be responsible for the following:
  - a. Providing administrative support to the Secretary-General office.

As part of the implementation of the provisions of Federal Law No. (7) of 2008 concerning the National Centre for Documentation and Research, and in response to the request of the aforesaid centre, all entities in the Emirate shall be prohibited from destroying any document or file unless specifying methodology of destruction has been specified in collaboration with the Governmental Establishments Archiving Committee in the National Centre for Documentation and research.
