

Law No. (15) of 2009 amending Law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Foundation

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi;

Having reviewed:

- -Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments:
- -Law No. (2) of 1971 concerning the National Advisory
 Council and its amendments;
- -Law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Foundation; and
- -Based on what was presented to and approved by the Executive Council;

Issued the following law:

Article (1)

The name (Khalifa bin Zayed Foundation) shall be replaced by the name (Khalifa bin Zayed for Humanitarian Acts Foundation) wherever it is mentioned in law No. (20) of 2007 and its amending law.

Article (2)

Article (7) of law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Foundation

as amended by Law No. (26) of 2007 shall be amended as follows:

- "The foundation's director-general is its legal representative and the responsible for its management and for the implemention of its policy, in accordance with the provisions of this law, the applicable laws and council resolutions, and in particular he shall assume the following:
- 1.Suggest action plans and the priorities of their implementation, as well as the projects and programmes necessary for the implementation of the same.
- 2.Run and supervise the work in the foundation in accordance with the applicable rules and regulations.
- 3. Prepare the foundation's draft annual budget together with its closing account and submit the same to the council for approval.
- 4. Represent the foundation before the governmental and judicial entities and the other concerned institutions, entities and authorities.
- 5. Prepare drafts financial and administrative regulations necessary for the organisation of the work flow in the foundation, as well as the regulations for human resources and training programmes, and submit the same to the council.
- 6.Disburse expenditure from the approved budget in accordance with the foundation's approved financial and administrative regulations.

- 7.Prepare periodical reports on the progress of the foundation's work and submit the same to the council.
- 8.Any other functions decided by the council or the chairman.

Two new articles (6 bis, 6 bis 1) shall be introduced in law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Foundation, as amended by Law No. (26) of 2007 as follows:

Article (6 bis)

"An executive committee shall be formed in the foundation from the board members and others to supervise the implementation of the board policy, and it shall be delegated some of the authorities of the board; a resolution concerning its formation, competences and regulations shall be issued by the chairman."


Article (6 bis 1)

"The foundation shall have a director-general at an undersecretary grade, who shall assume the management of the foundation and the implementation of its policy, in accordance with the provisions of this law, the applicable laws and the council resolutions, and he shall be assisted by "a deputy" at an "executive director" grade.

This law shall be published in the Official Gazette and be effective from the date of its issuance.




