**Law No.(1) of 2010  
amending Law No. (20) of 2007 concerning the  
establishment of Khalifa bin Zayed Al Nahyan  
Humanitarian works Foundation and its  
amendments**

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi;

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Humanitarian Works Foundation and its amendments; and;
- Based on what was presented to and approved by the Executive Council;

Issued the following law:

**Article (1)**

Articles Nos. (1), (3), (5) and (6) of Law No. (20) of 2007 concerning the establishment of Khalifa bin Zayed Humanitarian Works Foundation shall be replaced by the following:

### Article (1) :

In the implementation of the provisions of this law, the following words and phrases shall have the meanings assigned to them unless the context otherwise requires:

Emirate	The Emirate of Abu Dhabi
Foundation	Khalifa bin Zayed Al Nahyan Humanitarian Works Foundation
President	The President of the Foundation
Vice-President	The Vice-President of the Foundation
Director-General	The Director-General of the Foundation
Deputy Director-General	The Deputy Director-General of the Foundation

### Article (3) :

The headquarters of the Foundation shall be in the city of Abu Dhabi. The Chairman may establish branches inside and outside the Emirate.

#### Article (5) :

1. The Foundation shall have a President and a Vice-President who shall replace the Chairman in his absence. The Foundation shall have a Director-General who shall manage the Foundation and implement its policies in accordance with the provisions of the law and the decisions of its Chairman. The Foundation shall also have a Deputy Director-General to replace the Director-General in his absence.
2. The President, Vice-President, Director - General and Deputy Director - General shall be appointed by an Amiri Decree.

#### Article (6) :

The President shall exercise the necessary competences to put into motion the Foundation's works to achieve its objectives. He may, in particular, assume the following:

1. Adopt the necessary plans to manage the Foundation and to invest its funds.
2. Issue the Foundation's articles of association, the organizational structure, the human resources regulations and all organizational, administrative and financial regulations.
3. Form permanent and temporary committees.
4. Approve the Foundation annual budget and final accounts.
5. Appoint auditors and specify their remunerations.

### **Article (2)**

1. The word (Board) shall be replaced by the word (President) wherever it occurs in the aforesaid Law No. (20) of 2007 and its amendments.
2. The phrase (Chairman of the Board) shall also be replaced by the word (President) wherever it occurs in any other legislation.

### **Article (3)**

Article No. (14) of Law No. (20) of 2007 shall be repealed.  
Article No. (6) bis of Law No. (10) of 2009 amending the aforesaid Law No. (20) of 2007 shall also be repealed.

### **Article (4)**

Any provision which contradicts or conflicts with the provisions of this law shall be repealed.

### **Article (5)**

Chairman of the Board (President) and Vice-Chairman shall continue to occupy the same positions as stated in Amiri Decree No. (29) of 2007.

### **Article (6)**

This law shall be published in the Official Gazette and be effective from the date of its issuance.

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (7) of 2004 concerning the establishment of Abu Dhabi Tourism Authority;
- Amiri Decree No.(16)of 2004 concerning the appointment of the board of directors of Abu Dhabi Tourism Authority;and
- Based on what was presented to and approved by the Executive Council;

Issued the following decree:

**Article (1)**

The Board of Directors of Abu Dhabi Tourism Authority shall be reformed as follows:

### **Article (2)**

The term of the board membership shall be five renewable years.

### **Article (3)**

The bonuses of the board members shall be specified by an Executive Council resolution.

### **Article (4)**

This decree shall be effective from the date of its issuance and shall be published in the Official Gazette.

We, Mohamed bin Zayed Al Nahyan, Crown Prince;  
Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No.(2) of 2004 concerning the establishment of Zayed High Foundation for Humanitarian Care, Special Needs and Minors Affairs; and
- Law No. (19) of 2009 concerning the establishment of Foundation for Social Welfare and Minors Affairs;

Issued the following resolution:

**Article (1)**

A temporary committee entitled "Committee for the Implementation of the Provisions of Law No.(19) of 2009" shall be formed with the membership of the following gentlemen:

1.Mubarak Matar Al-Humairi	Chairman
2.Yusuf Ali Rashed	Member
3.Amer Saeed Al-Ameri	Member

## Article (2)

The Committee shall assume the following functions:

- 1.Specify the optimal mechanism to implement the law.
- 2.Oversee the procedure of transferring the Social Welfare and Minors Affairs Authority staff to the Foundation.
- 3.Oversee the inventory and transfer of the Social Welfare and Minors Affairs Authority assets to the Foundation.
- 4.Propose regulations, bylaws and resolutions and submit the same to the board of directors.
- 5.Specify the future needs of the Foundation.
- 6.Any other tasks and procedures necessary to implement the law.

## Article (3)

The Committee may form a team reporting to it to assist in performing its mandated functions. The Committee may also seek the assistance of whomsoever from experts and consultants as it deems appropriate.



#### **Article (4)**

The Committee must accomplish its missions within a period not exceeding two months starting from 18 November 2009 {the issuance date of Law No. (19) of 2009}.

#### **Article (5)**

The resolution shall be effective from the date of its issuance and shall be published in the Official Gazette.
