Article (1)

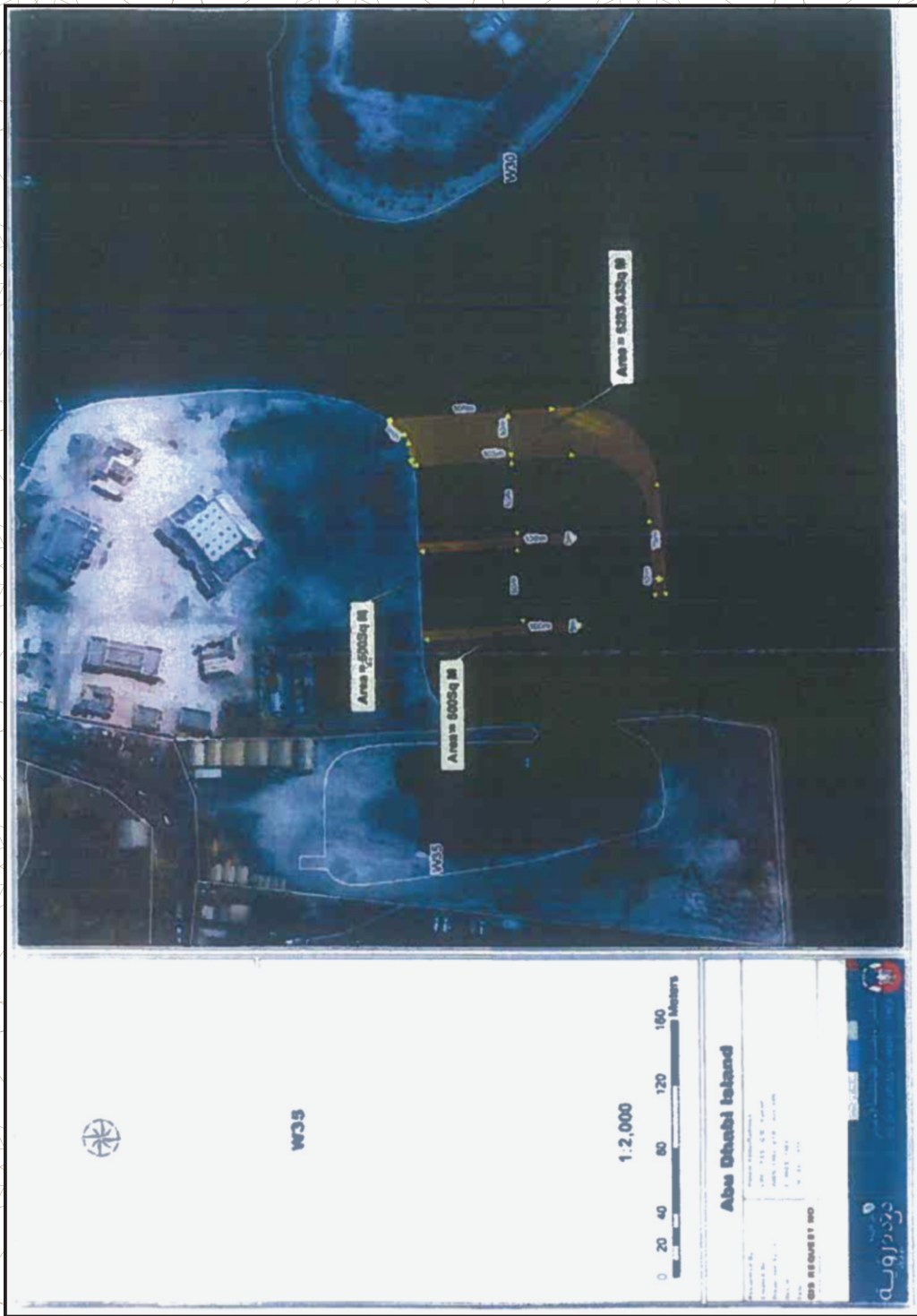
A marina shall be allocated to Emirates Heritage Club in Zayed Aladl Centre in Al Batteen according to the boundaries specified in the attached map.

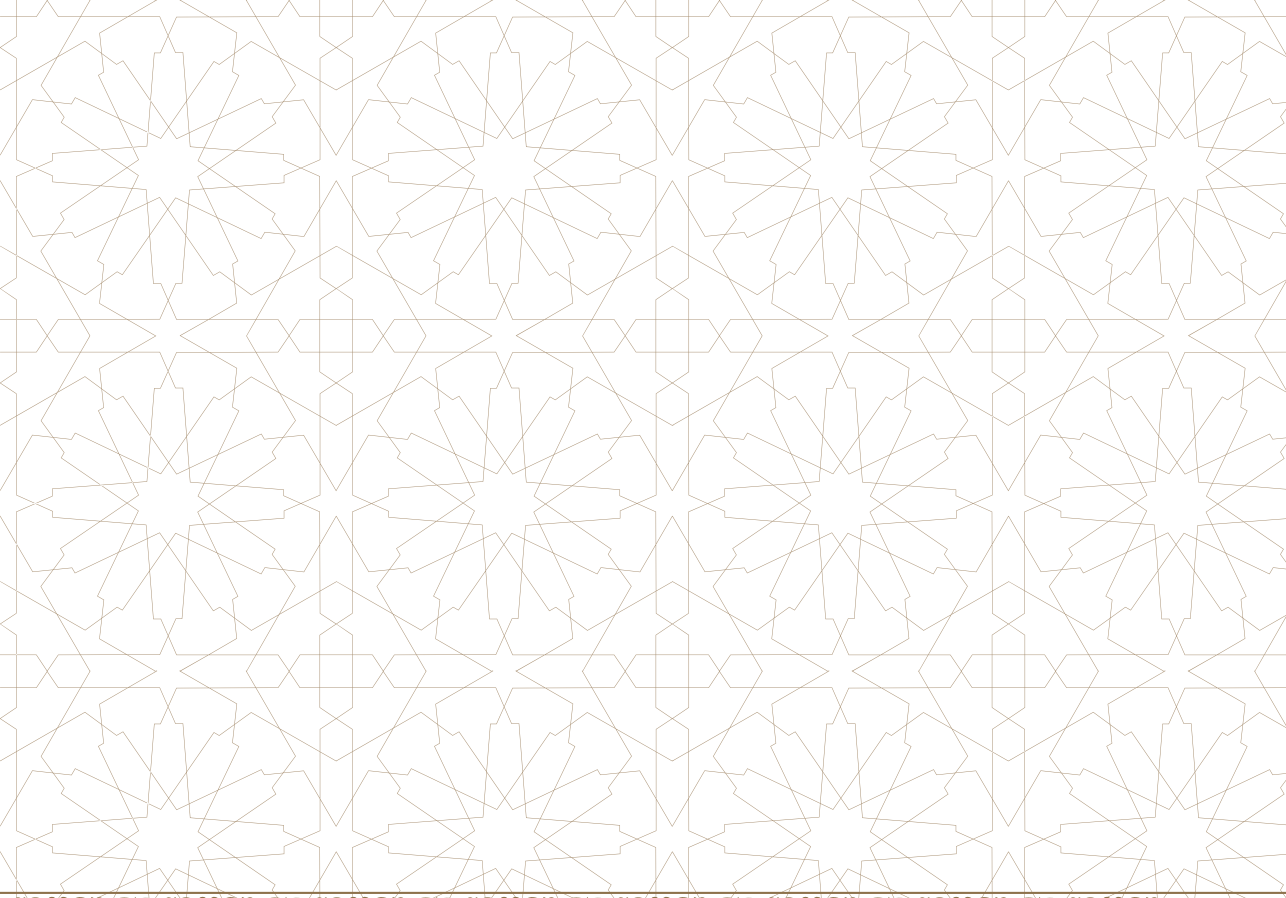

Circular No. (11) of 2010 concerning qualifying and training of national cadres

**To all governmental departments and entities in the Emirate
of Abu Dhabi**

Reference to Circular No. (5) of 2010 of H.E Secretary General of the Executive Council issued by the General Secretariat of the Executive Council on 25/8/2010 concerning qualifying and training of national cadres through the Fellowship Programme with Harvard Kennedy College designed to enhance the leadership skills of this category, please be advised that such programme includes the Master's degree in public administration as a part of Edward S. Mason Programme presented by Kennedy College specifically designed to support the promising leaders from emerging-economy countries.

These fellowships will provide their holders a wide range of up-stream activities, including seminars designed to enhance the essential leadership skills, public speaking workshops, supervising and networking opportunities.

Moreover, kindly note that the General Secretariat's role shall be limited to review the lists of candidates , support them during the final refinements, and carry out procedures for the College admission for the qualified ones. Taking into account that the conditions and procedures for nominating qualified candidates from governmental

departments and entities to the General Secretariat shall be as follows:

Candidates must meet the following conditions:

- Being a citizen of the United Arab Emirates.
- Having seven years practical experience.
- Having a leading and affecting personality capable to face the challenges.
- Having a distinguished record of professional achievements in public service field.
- Having a university degree with a grade of very good at least.
- Being ready to spend a full academic year in Harvard College in Boston, U.S.A.
- Having the ambition and desire to continue working in the public sector at the end of the study.
- Being able to obtain the College acceptance of his/her candidacy application, as the College shall have the final decision to approve the candidates admission who must attach the following documents to their applications:

- A number of written suggested subjects.
- Three recommendation letters.
- Academic scripts for the educational qualification.
- TOEFL certificate.

In addition, the governmental entity must send the candidate's CV, along with two letters of recommendation, one of which to be issued by the department undersecretary. Kindly forward the candidacy letters no later than 14/10/2010.
