

A specialised study requested by the Department from the Beneficiary Entity to specify the number and type of trips resulting from the project, how they are distributed on current and planned road networks and transportation systems, so as to lay down traffic solutions and to specify the number of parking lots required for the project's service.

Article (2)

The Department shall specify the requirements, standards and technical manuals related to the Traffic Impacts Study of the project and approve the necessary traffic solutions therefor.

Article (3)

- The Beneficiary Entity shall carry out the Traffic Impact Study of a project. Building permits shall not be issued for any project unless the Beneficiary Entity completes the Traffic Impact Study and obtains the Department's approval on the same.
- for approving Traffic Impact Study within (60) sixty days from the date when the application meets the applied terms and conditions of the Department, otherwise the application shall be considered as accepted.

Article (4)

- The Beneficiary Entity shall abide by the results of the project's

 Traffic Impact Study and any required traffic solutions.
- The Department shall specify the ratio of the necessary project costs of the Traffic Solutions to be borne by the Beneficiary
 Entity pursuant to the manual approved by the Executive Council.

Article (5)

The Beneficiary Entity shall be committed, when so entrusted, to execute the Traffic Solutions according to the drawings and designs approved by the Department and to complete the same within the specified period.

Article (6)

The Department may take any necessary procedures to ensure the execution of the traffic solutions, including the execution at the expense of the Beneficiary Entity, in coordination with the competent entities.

Article (7)

The Department shall collect the fees specified in the attached table.

Article (8)

The head of the Department shall issue the necessary resolutions to implement the provisions of this resolution.

Article (9)

This resolution shall be published in the Official Gazette and effective from the date of its issuance.

The following competencies shall be added to those already entrusted to the Department pursuant to Article (2) of the aforesaid Law No. (9) of 2007:

- 1. Propose the operational frame for familiarising roles and responsibilities entrusted to the Concerned Entities of the addressing system, in addition to the policies, specifications and mechanisms related to this frame and submit the same to the Executive Council for approval.
- 2. Develop and manage an electronic system for the addressing system data and ensure coordination between all governmental entities to execute their functions.
- 3. Unify, update and circulate addressing data to the Concerned Entities.
- 4. Lay down plans and procedures with the Concerned Entities to ensure dissemination, provision and update of maps, sign boards and electronic data for institutions, residents and visitors of the Emirate.
- 5. Coordinate with local, regional and international organisations concerning initiatives and studies related to the addressing system.

Article (3)

The Department may form work groups from the Concerned Entities to study and discuss any matter related to its competences in order to take the necessary decision.

Article (4)

All Concerned Entities in the Émirate shall cooperate with the Department and provide it with the necessary support towards achieving the common interest.




