- Law No. (1) of 2006 concerning civil service in the Emirate of Abu Dhabi as amended by Law No. (1) of 2008; and
- Based on what was presented to and approved by the Executive Council;

Issued the following resolution:

Article (1)

This resolution shall be effective from the date of its issuance and published in the Official Gazette.



Circular No. (10) of 2011
concerning the mandatory of the identity card
for nationals working in the Emirate

To all governmental and quasi-governmental entities in the Emirate

We extend to you our cordial greetings and appreciation for your sincere efforts exerted in serving this country; and in support of the initiatives of United Arab Emirates Government, we call all nationals working in governmental and quasi-governmental entities in the Emirate of Abu Dhabi, to the necessity and importance of registering in the Identity Card System and Population Register, in implementation of Article No. (10) of Federal Law No. (9) of 2006 concerning the Population Register and Identity Card System which stipulates that: (it is prohibited to accept, employ, or retain any individual whether as an employee, worker, labourer, student or in any other capacity unless such individual holds an identity card).

We also refer to the deadline specified by the Council of Ministers for registering all nationals in the Identity Card System, which expires at the end of June of the current year, 2011, and that the legislative entities in the State are working on activating fines against those who have not taken the steps to obtain an identity card.

Accordingly, we request all those who have not registered in the Identity Card System and Population Register to do so promptly for the common interest of all.

concerning the principles and controls
of issuing legislations

To all governmental departments and entities in the Emirate

After Greetings,

In pursuit to secure firmly the principles of governance and achieve its objectives of creating a work environment distinguished with efficiency, transparency and compliance with applicable laws and procedures;

And confirming the competency of the Executive Council in approving draft laws and decrees before submitting the same to the Ruler for his approval to be issued pursuant to the provisions of Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi, in addition to emphasize the essential and important role of the General Secretariat of the Executive Council pursuant to Law No. (2) of 2006 which entrusted the General Secretariat to study draft laws, decrees, regulations, resolutions, bylaws and agreements prior to their submission to the Executive Council for approval;

And as the Legal Affairs Division in the General Secretariat of the Executive Council is the sole entity entrusted with the preparation and revision of the legislations in the Emirate, and as it represents the Emirate of Abu Dhabi in the Technical Committee of Legislations to discuss federal legislations;

You are therefore kindly requested to adhere to the following:

First : To coordinate with the Legal Affairs Division in the General Secretariat before commencing to prepare the legislations that you submit to the Executive Council.

Second : To refrain from expressing opinions or comments, as is required from you concerning the federal legislations, except through the Legal Affairs Division in the General Secretariat.

concerning the rationalisation of energy usage

To all governmental entities in the Emirate

Peace and Allah's mercy and blessings be upon you,

Further to our previous Circular No. (9) of 2011 concerning the reduction of pollution level in cities and the rationalization of energy usage, and in order to achieve the supreme objectives relating thereto, MASDAR company has conducted a detailed study concerning the use of high efficiency lighting units (HELUs) instead of the units currently used so as to achieve the highest level of efficiency; furthermore, HELUs reduce carbon emissions and rationalize energy consumption.
