Article (1)

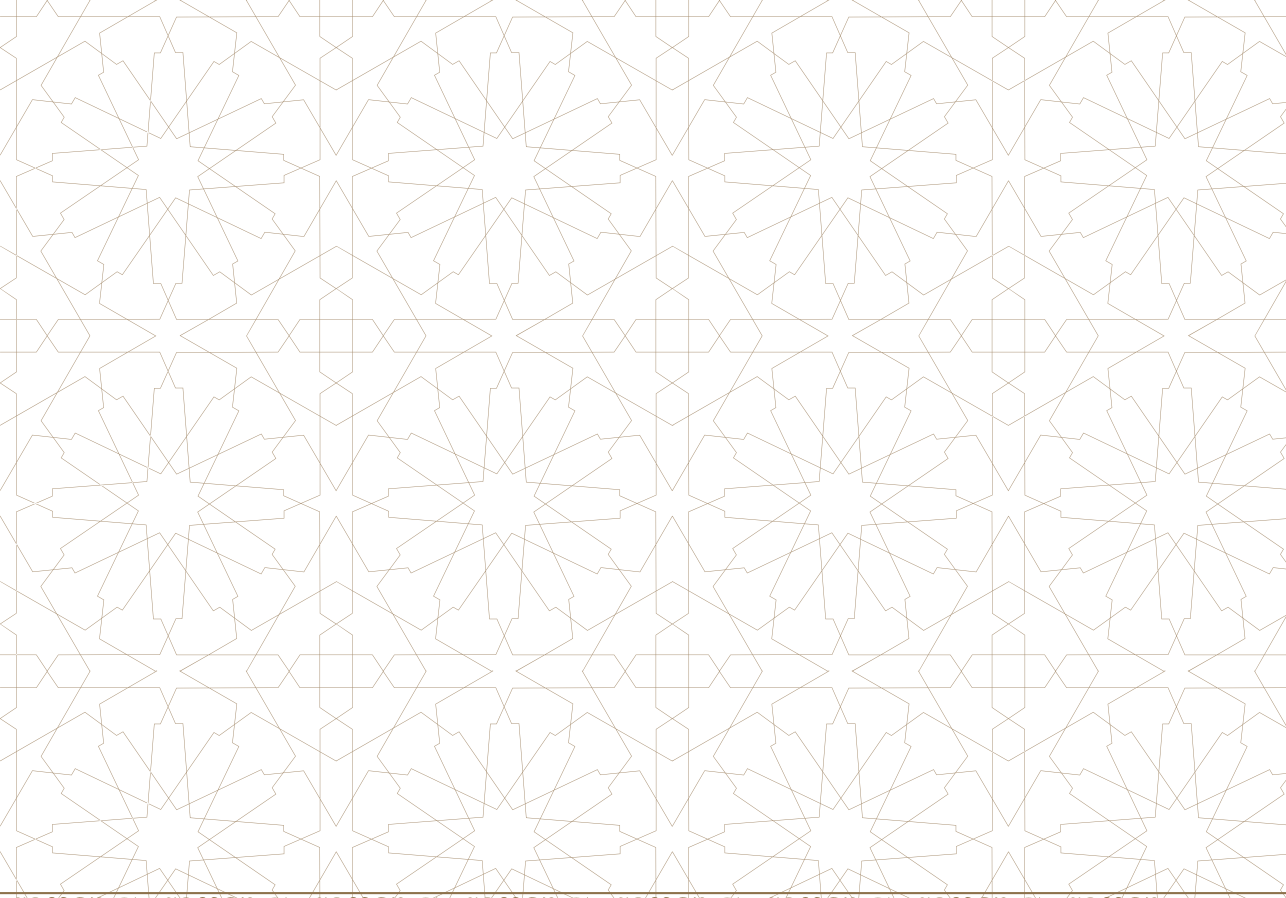
