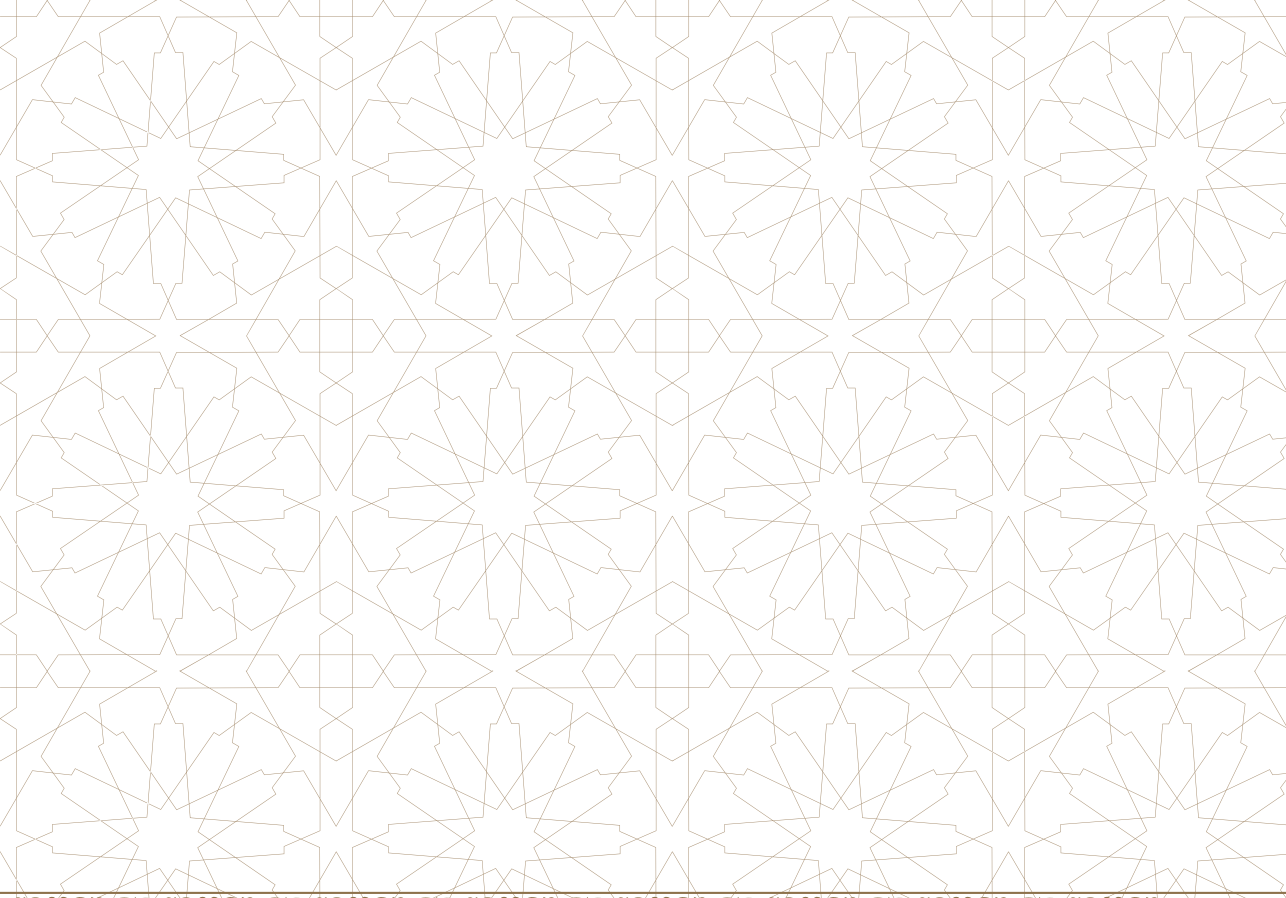
The Supervision Committee of Passengers and Commodities Train Project, formed pursuant to our aforesaid Resolution No. (35) of 2009, shall be canceled.
