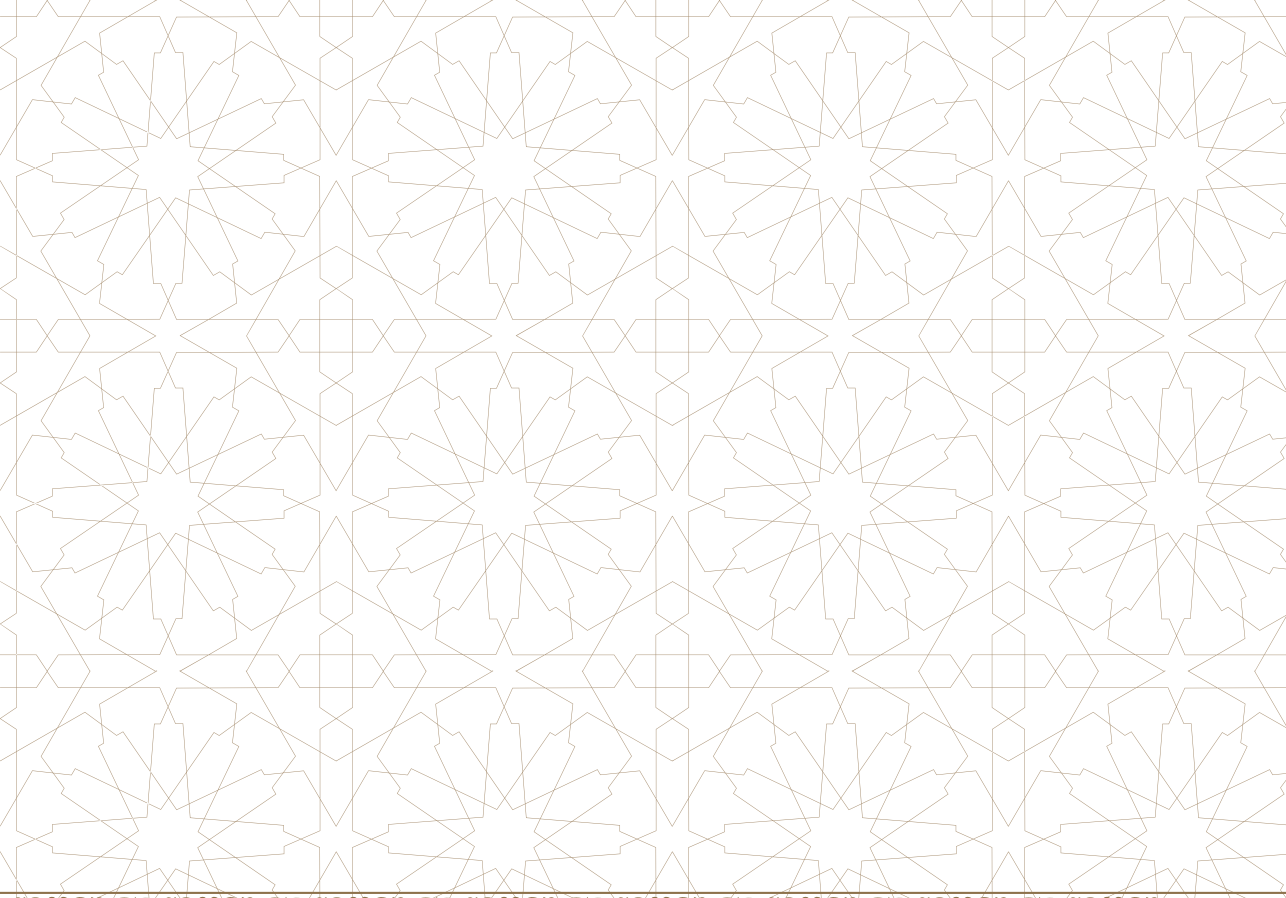

**To all governmental departments, entities and companies in
the Emirate of Abu Dhabi**

Peace and Allah's mercy and blessings be upon you,
Pursuant to Executive Committee Resolution No. (22)
S 18/2012 dated 20/6/2012 concerning the mechanism
of assessing any updates on the procedures or fees
increments related to commercial licenses, kindly refrain
from applying any updates on procedures or fees related
to commercial licenses until they have been assessed
by Abu Dhabi Competitiveness Office in preparation for
their approval by the Executive Council, according to the
following mechanism:

1. Submit the proposal of updating a procedure or fee to
Abu Dhabi Competitiveness Office for assessment within
two weeks.
2. Should the office approve the proposal, the same shall
be submitted to the General Secretariat of the Executive
Council to present it to the Executive Council for approval.

3. Should there be a need for further study, a work team shall be formed under the leadership of Abu Dhabi Competitiveness Office and the membership of the relevant entities to study the update and assess its effect on the business environment in the Emirate.
