Secretary-General Resolution No. (12) of 2012 concerning the formation of a committee to study the petrochemical industries sector in the Emirate of Aby Dhabi

Secretary-General of the Executive Council;

Having reviewed:

- -Law No. (1)of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- -Law No. (7) of 1971 concerning the establishment of Abu Dhabi National Oil Company and its amendments;
- -Law No. (3) of 2004 concerning the establishment of the Higher Corporation for Specialised Economic Zones as amended by Law No. (24) of 2006;
- -Law No. (2) of 2006 concerning the General Secretariat of the Executive Council; and
- -Law No. (2) of 2009 concerning the establishment of the Department of Economic Development;

Issued the following resolution:

Article(1)

A committee to study the petrochemical industries sector in the Emirate of Abu Dhabi shall be formed, under the chairmanship of the Head of the Department of Economic Development and the membership of representatives from each of the following entities:

- 1. Department of Economic Development
- 2. Abu Dhabi National Oil Company (Adnoc)
- 3. Abu Dhabi National Chemicals Company
- 4. Abu Dhabi Basic Industries Corporation
- 5. Abu Dhabi Oil Refining Company (Takreer)
- 6. Abu Dhabi Polymers Company (Borouge)

Article(2)

The committee shall have the following competencies:

- 1. Study the current status of the petrochemical industries and the possibility of managing future petrochemical projects under one governmental entity to be determined whenever necessary and upon the recommendation of the committee in coordination with the concerned entities, and after the approval of the Executive Council.
- 2. Examine the possibility of benefitting from the previous experiences and studies including the experience of Abu Dhabi National Chemicals Company (ChemaWEyaat) in acquiring technology licences, and the initial memoranda of understanding concluded between Abu Dhabi Basic Industries Corporation (Adbic) and the international companies.
 - 3. Review the economic and technical feasibility studies of ChemaWEyaat's and Adbic's projects in order to reach an integrated and unified study.
- 4. Study the importance of the role of the foreign partner in manufacturing the special petrochemical products that require advanced technology.

- 5.Study the possibility of developing an infrastructure and community facilities for future petrochemical projects, as well as the transformational projects or other industries that are to be relied on them.
- 6.Study and propose the ideal distribution of the industrial plots of land.
- 7.Study the establishment of an integrated oil refining project along with a petrochemical complex outside the state as a leading project owned by the Emirate of Abu Dhabi.

Article(3)

The committee shall lay down proposals concerning the budget required for steering its business during its term of operation in light of the laid down plan.

Article(4)

- -The committee shall meet periodically and document its meetings.
- -The committee shall submit a monthly work flow report to the Executive Council.
- -The committee shall submit a report concerning its final recommendations to the Executive Council within six months from its formation.







- 2. Adjust the current situations in accordance with this circular no later than one year from the date of expiration of the current rental contracts.


