

# Law No. (2) of 2012 concerning the preservation of the general appearance, health and public peace in the Emirate of Abu Dhabi

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi; Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory
  Council and its amendments;
- Law No. (3) of 1995 concerning the preservation of the general appearance of buildings in the Emirate of Abu Dhabi;
- Law No. (9) of 2007 concerning the establishment of the Municipal Affairs Department;
- Federal Law No. (3) of 1987 concerning the issuance of the Penal Law and its amendments;
- Federal Law No. (35) of 1992 concerning the issuance of the Criminal Procedures Law and its amendments; and
- Based on what was presented to and approved by the Executive Council;

Issued the following law:

#### Article(1)

In the implementation of the provisions of this law, the following words and phrases shall have the meanings corresponding thereto unless the context requires otherwise:

Emirate of Abu Dhabi.

Department : Municipal Affairs Department.

Concerned Municipality: Abu Dhabi city Municipality,
Al - Ain Municipality, Western
Region Municipality or any
other municipality that may be
established in future in the

Emirate.

Public Places

Parks, deserts, beaches and roads and the like, irrespective of the restrictions that may be imposed on them.

Public Health

: All features and factors that are conducive to protect the health environment of the Emirate.

Disturbance

Anything that may cause harm or annoyance to others or constitutes a trespass on private or public property or safety,

which may negatively affect human physical, psychological or social safety, including but not limited to, individual or group behaviour which would restrict the freedom or sanctity of others and leads to panic, annoyance or provocation.

**Swimming Pools** 

Anthropomorphic, indoors or outdoors, supplied with controllable water flow through pipes used for swimming, diving or for leisure purposes, including public swimming pools.

General Appearance

Everything that preserve the cultural, architectural and aesthetic aspects of Public Places in the Emirate, including grass - covered spaces, pavements, buildings and their walkways, markets, fences and public roads. Behaviour and attitudes that may in any way impair this appearance are prohibited.

Municipal Slaughterhouses Any facility approved by the competent authority used for

the purpose of slaughtering livestock and preparing the same for human consumption in accordance with approved standard specifications.

**Public Peace** 

the residential Places, which ensures total comfort for the public free from any action that causes disturbance or noise in any form.

#### Article(2)

Any natural or legal person is prohibited from any action that may disturb or harm the General Appearance, Public Health or public peace of the Emirate.

#### Article(3)

The Head of the Department shall, post the approval of the Executive Council, issue the executive regulations and necessary resolutions to preserve the General Appearance and Public Health and Peace in coordination with the relevant entities, and to clarify the authorities of the concerned municipalities concerning the following matters:

- Preserving Public Places.
- 2. Limiting disturbance aspects.
- 3. Municipal Slaughterhouses.
- 4. Swimming Pools.
- 5. Health control on non-alimentary facilities.
- 6. Preserving General Appearance.
- 7. The use of satellite dishes.
- 8. Signboards.
- 9. Abandoned vehicles.
- 10. Preserving walls.
- 11. Camping and events.
- 12. Any other matters related to the General Appearance or Public Health and Peace pursuant to a resolution of the Chairman of the Executive Council.

#### Article(4)

The Concerned Municipalities shall have the right to impose the following administrative sanctions:

- 1. Warning.
- 2. Suspending the violating activity and seizing the used tools.
- 3. Removing the violation at the expense of the offender.
- 4. Suspending the licence or withdrawing it temporarily.

The Executive Regulations of this law shall determine the rules and norms imposing the administrative sanctions.

#### Article(5)

Pursuant to a resolution of the Executive Council, upon a proposal of the Head of the Department, the fees due for the services, licenses and permits concerning the implementation of the provisions of this law and the cases that may be exempted shall be issued.

#### Article(6)

- Without prejudice to any more severe penalty stipulated by any other law, anyone violates this law and the bylaws and resolutions issued in implementation thereof shall be sentenced to a fine not less than AED200 and not exceeding AED100,000. The court may order a temporary suspension of the license or its cancellation, and oblige the adjudged guilty to eliminate the causes of the violation at his own expense. It may also order the seizure of the equipment used in the violation or confiscation and disposal of the same.
- The penalty shall be doubled in case of repetition.

#### Article(7)

- Subject to the provisions of Article (2) of this law, pursuant to a resolution of the Head of the Department and post the approval of the Executive Council to the same, a schedule of the contraventions and the respective fines and administrative sanctions specified for the same with respect to the matters stipulated in the third Article of this law shall be issued.

- The competent investigating officer shall at drafting the contravention record offer reconciliation to the offender and record the same in such record.
- The offender who duly accepts reconciliation shall within a period not exceeding one month from the date when reconciliation was offered pay a sum equivalent to half of the value of the fine as specified in the aforementioned schedule, and such sums shall be transferred to the Finance Department.
- The criminal case shall be finally extinguished by the payment of the reconciliation sum, unless a judgment has been issued in the case.

#### Article(8)

The Head of the Judicial Department shall, in agreement with the Head of the Department, issue a resolution specifying the Concerned Municipalities employees who have the capacity of investigating officers regarding all crimes that may take place – in violation of the provisions of this law – within their area of competency, and related to their job functions.

#### Article(9)

- Law No. (3) of 1995 concerning preservation of the General Appearance of buildings in the Emirate of Abu Dhabi shall be repealed.

- Any text or provision contrary to or inconsistent with the provisions of this law shall be repealed.



#### To all governmental departments and entities in the Emirate of Abu Dhabi

Peace and Allah's mercy and blessings be upon you,
We are pleased to greet you and to extend our sincere
gratitude for your continuous cooperation to realise the
common interest.

In the framework of Abu Dhabi Government's efforts to enhance coordination and communication between the governmental departments and entities, we urge you to abide by the following rules and principles:

#### First: General Rules and Financial Systems:

- Link up with the financial management systems of the Department of Finance irrespective of the financial systems you may have.
- Apply the Unified Chart of Accounts issued by the Department of Finance, and work on building estimates of the general budget and expenditure on the items pursuant to this chart.
- Provide the Department of Finance with all required financial data and submit periodical reports as per its instructions.

#### Second: General Revenues and Realised Savings:

- Not to keep any revenues, security deposits or savings realised during the fiscal year, and ensure their immediate remission to the Department of Finance.
- Enter all expenditures without carrying out set off between expenditures and revenues, if any, irrespective of the independency of the entity.
- Independent governmental entities shall open a bank account for revenues, through which its revenues shall be regularly remitted to the Department of Finance as soon as they are collected.

#### Third: Bank Accounts:

- Coordinate with the Department of Finance in applying the Unified Treasury Account in accordance with the mechanism seen fit by the Department of Finance.
- Undertake to submit monthly reports of its accounts and respective balances therein to the Department of Finance and the General Secretariat of the Executive Council.
- Not to open any bank account without the approval of the Department of Finance.
