



Law No. (1) of 2013

concerning the amendment of certain provisions of Law No. (5) of 2010 concerning the Emblem of the Emirate of Abu Dhabi

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi;

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory
 Council and its amendments;
- Law No. (5) of 2010 concerning the Emblem of the Emirate of Abu Dhabi; and
- Based on what was presented to and approved by the Executive Council.

Issued the following law.

Article(1)

 The first Article of Law No. (5) of 2010 concerning the Emblem of the Emirate of Abu Dhabi shall be replaced by the following: "The Emblem of the Emirate of Abu Dhabi shall be in the shape of a falcon with two crossed daggers below it, surmounted from each side by a white and red flag with a banner of rectangular shape bearing the name (Abu Dhabi) itself surmounted by three domes, in accordance with the attached sample."

The frame of the Emblem may be gold, silver or black.

Article(2)

The second paragraph of the second Article of the aforesaid Law No. (5) of 2010 shall be replaced by the following:

The Executive Council shall issue the necessary guidance for the use of the Emblem of the Emirate of Abu Dhabi."

Article(3)

This law shall be published in the Official Gazette and be effective from the date of its issuance.

Having reviewed:

- Federal Law No. (4) of 1992 concerning the establishment and organisation of the Ministry of Higher Education and Scientific Research;
- The agreement concluded between the University of Mohammed V - Agdal (Rabat, Morocco) and Abu Dhabi Education Council on 12/2/2010 as amended on 6/4/2010; and

Based on what was presented to and approved by the Executive Council;
 Issued the following law:

Chapter One

Definitions

Article (1)

In the implementation of the provisions of this Law, the following words and phrases shall have the meanings corresponding thereto unless the context requires otherwise:

Emirate

Executive Council

Abu Dhabi Education Council

Competent Entities

University

Board

The Emirate of Abu Dhabi.

The Executive Council of the Emirate.

The Council established pursuant to Law No. (8) of 2008.

The Ministry of Higher Education and Scientific Research and Abu Dhabi Education Council.

The University of Mohammed V - Agdal -Abu Dhabi.

The University's Board of Trustees.

Chapter Two

The establishment of the University and its objectives

Article(2)

Pursuant to the provisions of this Law, a University to be known as (Mohammed V University – Agdal – Abu Dhabi) shall be established in the Emirate and shall have an independent legal personality, financial and administrative independence in all its affairs and full legal capacity, and it shall be wholly owned by Abu Dhabi Education Council.

Article (3)

The University's main office shall be in Abu Dhabi city. Branches may be opened inside or outside the Emirate, upon the Board's suggestion and pursuant to a resolution of Abu Dhabi Education Council, and upon the approval of the Executive Council.

Article (4)

- The University aims to contribute in enhancing the higher education opportunities in Islamic and other studies under the applicable legal system of the United Arab Emirates.
- The University offers academic certificates pursuant to the applicable academic regulations and the conditions specified by the Competent Entities.

Chapter Three

Administrative and academic organisation of the University

Article (5)

- The University shall have a Board of Trustees consisting of six members. Three of whom shall be nominated by the University of Mohammed V Agdal (Rabat Morocco) and the remaining three shall be nominated by Abu Dhabi Education Council, provided that the Chairman of the Board be a National.
- A resolution of the Chairman of the Executive Council concerning the formation of the Board shall be issued.
 - The term of board's membership shall be three renewable years for similar period(s).

Article (6)

The Board shall select a rapporteur and shall issue internal regulations organising the procedures of its meetings and the vote on its resolutions. In case of a tie in votes, the side of the Board's chairman shall prevail.

Article (7)

In coordination with the Competent Entities, the Board shall:

1. Approve the general policy and strategic plans of education in the University in accordance with the objectives for which it was established.

- 2. Approve the academic programmes and their durations.
- 3. Issue the academic calendar.
- 4. Grant the academic degrees pursuant to the applicable regulations.
- 5. Specify the University's fees in coordination with Abu Dhabi Education Council.
- 6. Any other competences entrusted to it by Abu Dhabi Education Council.
 - Subject to the provisions of Article (4) of this Law, the academic certificates issued by the University before the effective date of this Law shall be accredited.

Article (8)

- The University shall have:
- 1. A chancellor to be nominated by the University of Mohammed V Agdal (Rabat, Morocco).
- 2. A vice-chancellor for academic affairs to be nominated by the University of Mohammed V - Agdal (Rabat, Morocco).
- A vice-chancellor for administrative and financial Affairs to be nominated by Abu Dhabi Education Council.
- A Board resolution shall be issued to appoint the chancellor and his two deputies for three renewable years and to specify the competences and functions of each.

Chapter Four Faculty members

Article (9)

- Faculty members of the University shall be selected from the faculty members of the University of Mohammed V
 Agdal (Rabat, Morocco), on secondment to teach a course of study in a semester or more, according to the approved study plan by the University.
- The Board may select a faculty member by appointment or secondment of qualified staff from inside or outside the Emirate.

Chapter Five

Academic Programmes

Article (10)

After the Competent Entities' approval, the University shall offer academic programmes in Islamic studies to obtain Bachelor, Master and Doctorate degrees in this field. The University may also provide academic programmes to obtain university certificates in other fields in agreement with Abu Dhabi Education Council.

Article (11)

The internal bylaws shall specify the study period of the academic year in general, the duration of the semester,

how to assess students at the end of each semester in each course the student registered for, tuition fees to be paid by the student and the payment method, procedures of deciding on University applications, maintenance of security and order and other issues, in accordance with the conditions and standards specified by the Competent Entities.

Chapter Six

Financial Affairs

Article (12)

The University shall have an annual budget approved by the Board. The budget resources shall consist of

- 1. Tuition fees specified by the Board in coordination with Abu Dhabi Education Council.
- 2. Annual appropriations allocated from the budget of the Emirate, upon a recommendation of Abu Dhabi Education Council in coordination with the Board.
- 3. Revenues of the University movable and immovable assets.
- 4. Any other financial resources approved by Abu Dhabi Education Council upon the suggestion of the Board.

Article(13)

Disbursement from the University budget shall be according to the Financial Regulations approved by the Board in coordination with Abu Dhabi Education Council.

Article(14)

Abu Dhabi Education Council shall appoint an accredited financial auditor or more to review and audit the University accounts. The auditor shall have all the necessary authorities to review any document necessary to perform its work pursuant to the law. The auditor shall submit a report of his findings to Abu Dhabi Education Council and a copy of the same to the Board.

Article (15)

- The applicable civil service regulations, financial and procurement system in the Emirate shall apply to the University until the issuance of its rules in this regard.
- Law of civil pensions and retirement benefits effective in the Emirate shall apply to National staff of the University.

Article (16)

The University shall be exempted from all local taxes and fees.

Article (17)

The aforesaid agreement concluded between the University of Mohammed V - Agdal (Rabat, Morocco) and Abu Dhabi Education Council shall be terminated with the issuance of this law.

Article (18)

In coordination with the Competent Entities, the Board shall issue a resolution concerning the executive regulations and bylaws necessary to implement the provisions of this law.

Article (19)

This Law shall be effective from the date of its issuance and published in the Official Gazette.



- To have project management skills in dealing with the evaluation initiative.

To follow-up after various feedback reports.

- To be familiar with continuous improvement strategies and best practices.
- To be well aware of the evaluation process, services and functions (of the governmental entity) and the overall aspects of their processes and procedures, etc.
- To be familiar with performance improvement initiatives, projects and programmes.
- To be familiar with the comprehensive models, methods and concepts of quality and various best practices and their applications in the entity's field of operations.

Circular No.(3) of 2013

concerning activating Abu Dhabi Tawteen Council's electronic portal for employment processes

To all departments, entities and governmental companies in the Emirate of Abu Dhabi

Peace and Allah's mercy and blessings be upon you,

- In line with the Emirate's continuous endeavors towards jobs Emiratisation and activating Abu Dhabi Tawteen Council's electronic portal in relation to employment processes, kindly adhere to the following:
- 1. Use Abu Dhabi Tawteen Council's electronic portal at www.tawteencouncil.ae to directly enter your job vacancies and proceed with the procedures of employing jobseekers registered in the Council's database.
- 2. Submit an application to use Abu Dhabi Tawteen Council's electronic portal if the same has not been used by you to date.
- Employ Nationals first to fill your job vacancies.
- 4. If suitable candidates cannot be found through the electronic portal database, Nationals may be employed directly provided that the data in Abu Dhabi / Tawteen Council's electronic portal be immediately updated.

- 5. In exceptional cases, when the above clauses(3) and (4) cannot be applied, non nationals may be employed provided that they fill the vacancy form prepared specifically for this purpose through Abu Dhabi Tawteen Council's electronic portal system.
- 6. Adhere to and provide the templates and forms specified in the electronic portal with respect to the employment process.
- 7. Your performance reports with regard to the employment shall be measured through the use of Abu Dhabi Tawteen Council's electronic portal.
- 8. Abu Dhabi Tawteen Council will communicate with the concerned people in the Ministry of Labour to coordinate with them for the implementation of the same methodology with regard to the employment of Nationals and the supervision of the employment of non nationals in the private sector.
- 9. Abu Dhabi Tawteen Council will coordinate with the concerned people in the General Directorate of Residency and Foreigners Affairs to lay down a mechanism for issuing statistical reports about residency visas for your expatriate employees.


