

This Resolution shall be implemented from the date of its issuance.



To all governmental entities in the Emirate of Abu Dhabi,

In an effort to organise and manage land allocation and government headquarters in the Emirate of Abu Dhabi, please be informed that Abu Dhabi General Services Company (Musnada) is in the process of preparing a directory for the facilities occupied by governmental entities in the Emirate, for the purposes of limiting, maintaining and supervising the same. Therefore, we kindly ask you to adhere to the following:

1. Communicating with Abu Dhabi General Services Company (Musnada) whenever the need arises for additional headquarters, in order to receive guidance and benefit from the Company's services in this regard.
2. Obtaining the approval of the Executive Council when planning to move from any government headquarters before the actual relocation, including the customer service centres, in addition to submitting a detailed statement of the main reasons for this action.
3. Informing the Executive Council of the need to allocate lands or locations for your entity, supported by a detailed study on the need for this allocation and the reasons for choosing the location as well as by a statement of

the extent of compliance of your application with your strategic plans and budgets set apart for you, enclosed with a list of all lands and locations allocated for your entity within the geographical scope specified in the application.
