

Law No. (4) of 2012 Concerning the Establishment of Abu Dhabi Housing Authority

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi,

Having reviewed:

- Law No. (1) of 1974 concerning the Reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No.(3) of 2005 concerning the regulation of real estate registration in the Emirate of Abu Dhabi;
- Law No. (19) of 2005 concerning real estate property as amended by Law No. (2) of 2007;
- Law No. (9) of 2008 concerning the reorganisation of private housing loans for nationals;
- Chairman of the Executive Council Resolution No. (41) of 2009 concerning the formation of a committee for the allocation of lands and public housing for nationals and disposition thereof; and,
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

Chapter 1

Definitions

Article (1)

In application of the provisions of this Law, the following terms and expressions shall have the meanings assigned thereto, unless the context stipulates otherwise:

Emirate: the Emirate of Abu Dhabi

Supreme Orders: The Directives and orders issued by H.H Ruler of Abu Dhabi or H.H Crown Prince of Abu Dhabi.

Executive Council: The Executive Council of the Emirate.

Authority: Abu Dhabi Housing Authority.

Board of Directors: The Board of Directors of the Authority.

Director-General: The Director-General of the Authority.

Housing Programs: Everything related to housing issues such as the allocation of lands and public housing for nationals and the disposition thereof, the private housing loans granted to nationals and other programs developed by the Authority in the context of achieving its objectives and implementing the supreme orders.

Concerned Authorities: The government bodies and government-owned companies operating in the housing, financing, building and infrastructure sector as well as the other entities engaged in the development of housing.

Chapter 2

Establishment of the Authority, its Headquarters, Objectives and Competencies

Article (2)

A public authority shall be established by virtue of the provisions of this Law under the name of "Abu Dhabi Housing Authority", and shall have a juristic personality as well as full legal capacity to act. This Authority shall enjoy an administrative and financial independency required to achieve its objectives, and shall follow the Executive Council.

Article (3)

The headquarters of the Authority shall be located in Abu Dhabi. It may open branches and offices within the Emirate by virtue of a Board of Directors decision.

Article (4)

The Authority shall aim to provide the appropriate dwelling for nationals of the Emirate through implementing supreme orders, preparing the appropriate housing programs and overseeing the execution thereof as well as attracting and encouraging the private sector to invest in the fields of housing.

Article (5)

In order to achieve its objectives, the Authority shall have the following competencies:

- 1. Implementing the supreme orders related to housing programs in the Emirate.
- 2. Suggesting policies, strategies and legislations related to housing programs. For this purpose, the Authority may request data and information from the concerned authorities.

- 3. Determining the requirements needed for the implementation of the housing programs; Setting up the logistics for the infrastructure requirements as well as preparing the engineering services.
- 4. Developing housing programs as well as preparing the rules and regulations of every program, including the determination of the program objectives, mechanism of action and implementation plans, and the terms of housing allocation.
- 5. Preparing the budget for the execution of each of the housing programs.
- 6. Supervising and controlling the implementation of the plans and programs approved in coordination with the concerned authorities.
- 7. Maintaining a central data base for nationals, linking the same to the concerned authorities and verifying the confidentiality and security of such information.
- 8. Receiving nationals' applications related to housing programs of all kinds, studying the same and taking the appropriate decisions thereon in the light of supreme orders.
- Studying the applications of housing programs loans for nationals and taking the appropriate decisions thereon according to supreme orders.
- 10. Any other competencies entrusted to the Authority by the Ruler of Abu Dhabi, the Crown Prince or the Executive Council.

Article (6)

The Ministry of Presidential Affairs and the Crown Prince Court shall continue to receive nationals' applications.

Chapter 3

Management of the Authority Article (7)

- The Authority shall be managed by a Board of Directors consisting of no more than nine (9) members including the Chairman and the representatives of the Ministry of Presidential Affairs, to be nominated by the Minister of Presidential Affairs. They shall be appointed and their allocations determined by virtue of a resolution issued by the Chairman of the Executive Council.
- The term in office of the Board of Directors shall be two years renewable for similar periods.

Article (8)

The Board of Directors shall be the competent authority in charge of setting the general policy of the Authority and following up its implementation to achieve the Authoritys' objectives. This Board may exercise all powers and authorities required for this purpose, particularly the following:

- 1. Adopting the plans necessary for the implementation of the general policy of the Authority.
- 2. Suggesting the organisational structure of the Authority, determining the competencies, functions, administrations, divisions and administrative units therein and submitting the same to the Executive Council for approval.

- 3. Issuing the internal regulations of the Authority including the financial and administrative regulations and the human resources regulations.
- 4. Ratifying the draft annual budget and the balance sheet of the Authority and submitting the same to the executive Council for approval.
- 5. Issuing the internal regulations of the Board of Directors meetings.
- 6. Discussing and adopting the report of the external auditor.

Article (9)

The Authority shall be managed by a Director-General whose appointment and allocations shall be decided by virtue of a resolution issued by the Chairman of the Executive Council. This Director-general shall be responsible for running the daily work of the Authority and shall particularly exercise the following:

- 1. Suggesting the policies, plans and programs related to housing programs.
- 2. Suggesting the internal regulations of the Authority including the financial and administrative regulations and the human resources regulations.
- 3. Appointing the employees at the Authority and terminating their service within the limits stipulated by the regulations applied at the Authority.
- 4. Preparing the draft annual budget and the annual balance sheet of the Authority.
- 5. Setting up the mechanism of receiving nationals' applications regarding the housing program as well as the relevant loan applications in a manner that facilitates their review and search as well as linking it to the concerned authorities.

- 6. Implementing the decisions of the Board of Directors.
- 7. Representing the Authority before Courts and others.
- 8. Any other competencies entrusted thereto by the Board of Directors.

Chapter 4

Finance of the Authority

Article (10)

The Authority shall have an independent budget to be adopted and ratified according to the procedures in force. The Department of Finance shall cover the appropriations needed for the Authority according to the rules prescribed.

Article (11)

The funds and resources of the Authority shall consist of the following:

- 1. The annual appropriations allocated thereto by the government of Abu Dhabi.
- 2. The income generated by some services offered by the Authority according to the provisions of this Law.
- 3. Any other resources ratified or accepted by the Board of Directors.

Article (12)

The fiscal year of the Authority shall begin on the first day of January and shall end on the 31st of December of each year, except for the first fiscal year which shall start as of the enforcement date of this Law and shall end on the last day of December of the following year.

Article (13)

The Board of Directors shall appoint one external auditor or more of certified auditors in order to examine the accounts and financial data of the Authority. These external auditors shall be appointed and their remunerations shall be determined by virtue of a decision issued by the Board of Directors.

Chapter 5 Final Provisions

Article (14)

All the rights, obligations, assets and properties of the Private Housing Loans Authority and the Housing and Land Allocation Committee shall be transferred to the Authority.

Article (15)

The employees of the Private housing Loans Authority identified by virtue of a decision issued by the Chairman of the Board of Directors shall be transferred to the Authority under the same employment terms and privileges, after coordination with the Department of Finance.

Article (16)

- The employees of the Authority shall be subject to the civil service law and regulations in force within the Emirate regarding what was not provided for in this Law and its implementing regulations and resolutions.
- The nationals among them shall be subject to the Law of civil retirement pensions and benefits in the Emirate.

Article (17)

- Each of the Private Housing Loans Authority and the Housing and Land Allocation Committee shall continue their operation by virtue of their in force legislations for a transitional period of six (6) months or until the issuance of the resolutions and regulations governing the workflow at the Authority, whichever is earlier. This period may be extended by virtue of a decision issued by the Chairman of the Executive Council.
- A decision shall be issued by the Chairman of the Executive Council to dissolve each of the Private Housing Loans for nationals and the Housing and Land Allocation Committee at the end of the period mentioned in the previous paragraph of this Article.

Article (18)

The Authority shall be exempt from all local taxes and fees.

Article (19)

The provisions of the said Law No. (9) of 2008 shall continue to apply within the limits that do not contradict with the provisions of this Law and its implementing regulations.

Article (20)

The Authority shall issue all resolutions necessary for the implementation of the provisions of this Law.

Article (21)

• The aforementioned Chairman of the Executive Council Resolution No. (41) of 2009, shall be repealed after the end of the period referred to in Article (17) of this Law.

• Any text or provision contradicting or conflicting with the provisions of this Law shall be repealed.

Article (22)

This Law shall be effective from the date of its issuance date and published in the Official Gazette.

Law No. (9) of 2013 Concerning the Establishment of Al Dhafra Oil Operations Company Ltd. "Limited Liability Company"

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi,

Having reviewed:

- Law No. (1) of 1974 concerning the Reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (7) of 1971 concerning the establishment of Abu Dhabi National Oil Company and its amendments;
- Law No. (4) of 1976 concerning the Emirate of Abu Dhabis' Gas Ownership;
- Law No. (8) of 1978 concerning the preservation of petroleum resources;
- Law No. (1) of 1988 concerning the establishment of the Supreme Petroleum Council;
- Federal Law No. (8) of 1984 concerning the commercial companies and its amendments, and;
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

Article (1)

A company shall be established by virtue of the provisions of this Law under the name of "Al Dhafra Oil Operations Co. Ltd.", Limited Liability Company, having an independent legal personality and full legal capacity to exercise its activities and achieve its objectives.

Article (2)

The Companys' headquarters shall be located in the city of Abu Dhabi and the Board of Directors may establish branches, offices or agencies inside or outside the Emirate of Abu Dhabi.

Article (3)

The Companys' capital was fixed at USD (1,000,000) one million US Dollars, divided into (1,000,000) one million shares, the value of each share being one US Dollar.

The capital may be increased or decreased upon the suggestion of the Board of Directors and with the approval of both partners according to the Companys' articles of association.

Article (4)

The Companys' shares shall be nominal, indivisible and owned as follows:

- 1. Abu Dhabi National Oil Company (ADNOC) 60% (sixty percent).
- 2. KADOC Ltd. "Limited Company" 40% (forty percent).

The partners may decide to amend the above-mentioned ownership proportion, provided that the proportion owned by ADNOC in all cases is not less than 60%.

Article (5)

The total net profit (if any) shall be distributed between the partners according to the joint coalition and participation agreement signed on 05/03/2012 and any amendments thereto that may arise in the future.

Article (6)

- None of the partners shall transfer the ownership of any of its shares without the prior written consent of the Supreme Petroleum Council.
- Notwithstanding the provisions of the preceding paragraph, ADNOC may transfer all or some of its shares in the Company to another company wholly owned by it.
- •KADOC may transfer all and not some of its shares to another company, wholly owned by its current shareholders, provided that Korea National Oil Corporation owns more than 50% of the shares of that other company.
- Any transfer of shares by ADNOC shall not be taken in consideration if such was in violation of the provisions of this Article.

Article (7)

The Company shall only be liable for the obligations arising within the limits of its capital.

Article (8)

The objective of the Company is to develop the onshore and offshore areas in the Emirate of Abu Dhabi as per crude oil, approved by the Supreme Petroleum Council, and to develop Mandoos field in relation to gas only, and which includes the following:

- 1. Survey, exploration, evaluation, drilling and maintenance of wells as required for the extraction of crude oil from its reservoir.
- 2. Construction, operation and maintenance of all facilities necessary for the production, conversion, treatment, measurement, storage, transfer and delivery of crude oil from the production wells to the delivery points, including the necessary measurement facilities complying with the requirements of health, safety and preservation of the environment.
- 3. Marketing of crude oil or exporting it abroad.
- 4. Carrying out any other related activity that help the partners directly or indirectly in the achievement of profits and benefits.
- 5. Carrying out all the activities set forth in this Article and related to gas in Mandoos field as stated in Law No. (4) of 1976 concerning the ownership of gas by the Emirate of Abu Dhabi.
- 6. The Company may, in order to achieve these purposes, proceed with all the operations and actions required for the performance of its work inside or outside Abu Dhabi and any other work or activity deemed necessary for its objectives.
- 7. Carrying out any other purposes with the approval of the Supreme Petroleum Council.

Article (9)

The Company shall be managed by a Board of Directors formed under agreement of both parties and having full authority to manage the Company according to this Law, the Companys' articles of association and the coalition and

participation agreement concluded between both partners, as well as any amendments occurring thereto.

Article (10)

The Company shall appoint one or more auditors approved in the Emirate. Their appointment and the determination of their fees shall be set forth in a decision issued by the Board of Directors and approved by both partners.

Article (11)

The period of the Company shall be 30 (thirty) Gregorian calendar years, with effect from the date of issuance of this Law, renewable under a decision from both partners. The Company may be dissolved before the end of its period according to a decision issued by both partners.

Article (12)

The Company shall operate according to the articles of association acknowledged by both partners. Such articles of association shall state the method of formation of the Board of Directors, the procedures of its meetings and the method of voting upon the decisions thereof.

Article (13)

The Company shall have the priority to implement a program for the employment and training of UAE citizens and their provision with technical and managerial capabilities that enable them to carry out the Companys' works and activities.

Article (14)

The Company shall be exempted from all local taxes and fees.

Article (15)

This Law shall be effective from the date of its issuance date and published in the Official Gazette.

Law No. (10) of 2013 Amending Certain Provisions of Law No. (19) of 2005 Concerning Real Estate Property

Issued the following Law:

Article (1)

The first paragraph of Article (3) of said Law No.(19) of 2005 shall be replaced by the following text:

"The right to own real estate is confined to nationals and the like as well as persons, companies and entities determined by virtue of a resolution issued by the Crown Prince or the Chairman of the Executive Council."

Article (2)



Issued the following Resolution:

Article (1)

The financial allocations for the sports clubs in the Emirate of Abu Dhabi shall be as follows:

Article (2)

A financial remuneration shall be set, by a decision of the Head of Abu Dhabi Sports Council, for every athlete registered in the clubs of the Emirate of Abu Dhabi who achieves an individual accomplishment for the Country, as follows:

- 1. AED 200,000 as a maximum for those with special needs.
- 2. AED 50,000 as a maximum for any championship other than those stated in Article (1)/13, 1.
- 3. AED 30,000 as a maximum for the age groups (junior, youth).

Article (3)

Any sports club, association, academy or foundation hosting, organizing or participating in any sports event shall commit to the following:

- 1. Standards and conditions of Abu Dhabi Sports Council, provided that the latter is the sponsor of such championship. The Council may verify the classification and approval of the above concerning the organization of tournaments from the competent authorities.
- 2. Submitting an estimated budget of the event to the Abu Dhabi Sports Council in case the event is not stated in this Resolution. The Head of the Council may estimate the value of the support related to such event.

Article (4)

- 1. Any club hosting or organizing tournaments (equestrian sports, marine sports, traditional sports) shall submit an annual estimated budget of the cash prizes. The Head of the Council may estimate the value of the support related to the same and shall include the value of the cash prizes within its annual budget and set the convenient disbursement mechanism.
- 2. Any sports club, association, academy or foundation classified according to the levels stated in this Resolution, shall submit its procedural annual plan to Abu Dhabi Sports Council. Otherwise, Abu Dhabi Sports Council shall have the right to withhold support by virtue of a decision issued by the Head of the Council.

Article (5)

The provisions of the said Crown Prince Resolution No. (60) of 2008 shall remain in force until 31/12/2012.

Any provision violating or contradicting the provisions of this Resolution shall be repealed.

Article (6)

This Resolution shall enter into force on 01/01/2013 and shall be published in the Official Gazette.


