We, Mohamed bin Zayed Al Nahyan, Crown Prince, Chairman of the Executive Council,

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Chairman of the Executive Council Resolution No. (3) of 2009 concerning the Executive Committee, as amended by Resolution No. (15) of 2014, and
- Based on what was presented to and approved by the Executive Council; Issued the following Resolution:

Article (1)

The appropriation set for the Executive Committee shall amount to AED 120,000,000 (One Hundred and Twenty Million Dirhams) and the Committee shall assume the following competencies:

- 1. Reviewing the matters brought forth before the Executive Council, analysing their elements, ensuring fulfilment of their data and documents and submitting recommendations in their respect.
- 2. Guiding the sub-committees and governmental entities and following up on their performance to enhance the level of services in the Emirate.
- 3. Issuing resolutions and deciding upon the projects, tenders, variation orders, additional work, delay fines and payments due to the contractors, which are presented to the Executive Council and upon which recommendations are issued by sub-committees, within the limits of amounts not exceeding AED 120,000,000 (One Hundred and Twenty Million Dirhams).

- 4. Reviewing the general budget of the Emirate and submitting same to the Executive Council for approval.
- 5. Giving preliminary approval of the list of new capital projects in preparation for its study by the Department of Finance, including said list in the draft general budget and submitting same for final approval according to the followed systems.
- 6. Deciding upon the applications for allowances and bonuses for the employees or the boards of directors according to the systems adopted; and submitting them to the council when necessary.
- 7. Reviewing the financial performance reports according to the followed systems.
- 8. Reviewing the final accounts of the Government of Abu Dhabi and submitting same to the Executive Council for approval.
- 9. Reviewing and studying the general policies and comprehensive strategic plans of the Emirate and working on adapting and coordinating them with each other and submitting the said to the Executive Council for approval.
- 10. Supervising laying down the Emirates plan, including the objectives, programmes, indicators etc.
- 11. Considering the strategic challenges and risks.
- 12. Studying the improvement of governmental administration through the consideration of financial policies, procurements, information technology, human resources, communication, statistics and other elements in governmental entities.

- 13. Studying the legislations submitted by the entities before presenting same to the Executive Council.
- 14. Studying and assessing the general government performance.
- 15. Studying the recommendations of sub-committees with respect to the conduct of work of the various sectors, specifying the role of certain entities in the event of differing entities and roles and taking necessary decisions in light of the applicable legislations.
- 16. Suggesting standards for the performance reports of sub-committees and their members and submitting such standards to the Executive Council.
- 17. Any other functions or duties assigned to the Committee by the Executive Council.

Article (2)

The Chairman of the Executive Committee shall be responsible for guiding said Committee to discuss important issues in the Emirate. For this purpose, the Chairman may assume the following competencies:

- Approving the agenda set for the Committee's meetings.
- Chairing the sessions, managing the discussions and studying any additional works.
- Approving the minutes of meetings after having been signed by the members.
- Assigning any Committee member he deems appropriate to chair the sessions in his absence.

Article (3)

The aforementioned Chairman of the Executive Council Resolution No.(3) of 2009 shall be repealed.

Article (1)

The Infrastructure and Environment Committee shall be formed under the Chairmanship of H.E. Chairman of the Department of Municipal Affairs and the membership of their Excellencies and gentlemen:

- 1. Undersecretary of the Department of Transport.
- 2. Secretary-General of the Environment Agency Abu Dhabi.
- 3. Director-General of Abu Dhabi Urban Planning Council.
- 4. Director-General of Abu Dhabi Water and Electricity Authority.
- 5. Director-General of the Regulatory and Supervisory Bureau for Electricity and Water.

- 9. Representative of the Department of Municipal Affairs.

The member of the Committee shall be a National. Should this requisite could not be fulfilled or should the position be vacant, another member occupying the next functioning level shall be appointed by a resolution of the Executive Committee based on the proposal of the entity represented at the Committee, provided that the nominated member is being appointed from the same entity.

Article (2)

The Committee's scope of work shall include the supervision of several areas, including:

- Public infrastructure.
- Transport.
- Urban planning and development.
- Water, electricity and sewerage services.
- Environment.
- Government capital projects.
- Electronic government.
- Any other matters specified by the Executive Committee.

Article (3)

The appropriation set for the Infrastructure and Environment Committee shall be AED 20,000,000 (Twenty million Dirhams only), and the Committee shall assume the following competencies within its scope of work:

- Reviewing the current situation and determining the government objectives related to its scope of work; reviewing the strategic plans, and the programs and services related to it as per the priorities approved and the expenses limit specified.
- 2. Conducting a preliminary study of the draft public budget submitted by the entities and then referring the same to the Department of Finance so that it may prepare the detailed financial study and make recommendations thereon to the Executive Committee.
- 3. Awarding the tenders of work implementation contracts (projects) as per the appropriations.
- 4. Studying the new capital projects which are not approved within the public budget and making any recommendations thereon to the Executive Committee.
- 5. Studying the matters related to the applications for supplementary budgets and their amendments and submitting the same to the Executive Committee.
- 6. Studying infrastructure matters such as the claims of contractors, developers and consultants as well as the compensation for lands and deciding thereon as per the applicable regulations.
- 7. Studying the planning of areas, the applications for the allocation of lands and buildings and the matters related to government headquarters, and making recommendations thereon.

- 8. Periodically monitoring and evaluating the performance of the entities in terms of implementing the strategies, objectives, programs, services, budgets and resolutions of the Executive Council and its Committees; taking corrective actions to ensure the achievement of their objectives and submitting the necessary recommendations thereon to the Executive Committee.
- 9. Supervising the plans of the capital projects and their level of implementation.
- 10. Revising the operating system used by the entities to verify its capability of implementing the public policies and submitting any proposals to the Executive Committee.
- 11. Revising and monitoring the challenges and risks facing the entities and submitting reports thereon to the Executive Committee.
- 12. Looking into the legislations of the entities and making recommendations thereon to the Executive Committee.
- 13. Looking into the applications of the entities and deciding thereon according to the appropriations.
- 14. Forming working groups from government entities or others, to provide support to the committee in specific matters. The Committee shall be in charge of following up the working groups affiliated thereto through the General Secretariat of the Executive Council.
- 15. Evaluating the need for the committees previously formed by virtue of resolutions of the Executive Council and its committees in the Emirate, and deciding thereon according to the applicable regulations.

- 16. Referring some of the matters to any other entities or sub-committees for considering the same and expressing an opinion thereon.
- 17. Any other tasks entrusted thereto by the Executive Committee.

Article (4)

- 9. Forming working groups from government entities or others, to provide support for the committee in specific matters. The Committee shall be in charge of following up the working groups affiliated thereto through the General Secretariat of the Executive Council.
- 10. Evaluating the need for the committees previously formed by virtue of resolutions of the Executive Council and its committees in the Emirate, and deciding thereon according to the applicable regulations.
- 11. Referring some of the matters to any other entities or sub-committees for considering the same and expressing an opinion thereon.
- 12. Any other tasks entrusted thereto by the Executive Committee.

Article (4)

- The Chairman shall be responsible for directing the Committee, and he may for this purpose assume the following:
- 1. Approving the agenda suggested for the Committee's meetings.

Issued the following Resolution:

Article (1)

- The Security, Justice, and Safety Committee shall be formed under the chairmanship of H.E. Deputy Commander General of Abu Dhabi Police, and the membership of their Excellencies:
- 1. Undersecretary of Abu Dhabi Judicial Department.
- 2. Director-General of Customs / Department of Finance.
- 3. Director-General of Abu Dhabi Food Control Authority.
- 4. Director-General of the Follow-up and Control Centre.
- 5. Director-General of the Centre for Occupational Health and Safety / Environment Agency Abu Dhabi.

- 6. Director-General of the Headquarters Affairs at Abu Dhabi Police GHQ.
- 7. Director of the Abu Dhabi Civil Defence General Directorate.
- 8. Director of the Abu Dhabi Residency and Foreigners Affairs General Directorate.
- The member of the Committee shall be a National. Should this requisite
 could not be fulfilled or should the position be vacant, another member
 occupying the next functioning level shall be appointed by a resolution
 of the Executive Committee based on the proposal of the entity represented
 at the Committee, provided that the nominated member is being appointed
 from the same entity.

Article (2)

The Committee's scope of work shall include the supervision of several areas including:

- Police.
- Security and combating crime.
- Traffic safety.
- lustice.
- Civil Defence.
- Immigration and passports affairs.
- Crisis, disaster and emergency management.
- Business continuity.
- Agriculture and food safety.
- Occupational safety.

- Any other matters specified by the Executive Committee.

- 2. Conducting a preliminary study of the draft public budget submitted by the entities and then referring the same to the Department of Finance so that it may prepare the detailed financial study and make recommendations thereon to the Executive Committee.
- 3. Studying the matters related to the applications for supplementary budgets and their amendments and submitting the same to the Executive Committee.
- 4. Periodically monitoring and evaluating the performance of the entities in terms of implementing the strategies, objectives, programs, services, budgets and resolutions of the Executive Council and its Committees; taking corrective actions to ensure the achievement of their objectives and submitting the necessary recommendations thereon to the Executive Committee.

- 5. Revising the operating system used by the entities to verify its capability of implementing the public policies and submitting any proposals to the Executive Committee.
- 6. Revising and monitoring the challenges and risks facing the entities and submitting reports thereon to the Executive Committee.
- 7. Looking into the legislations of the entities and making recommendations thereon to the Executive Committee.
