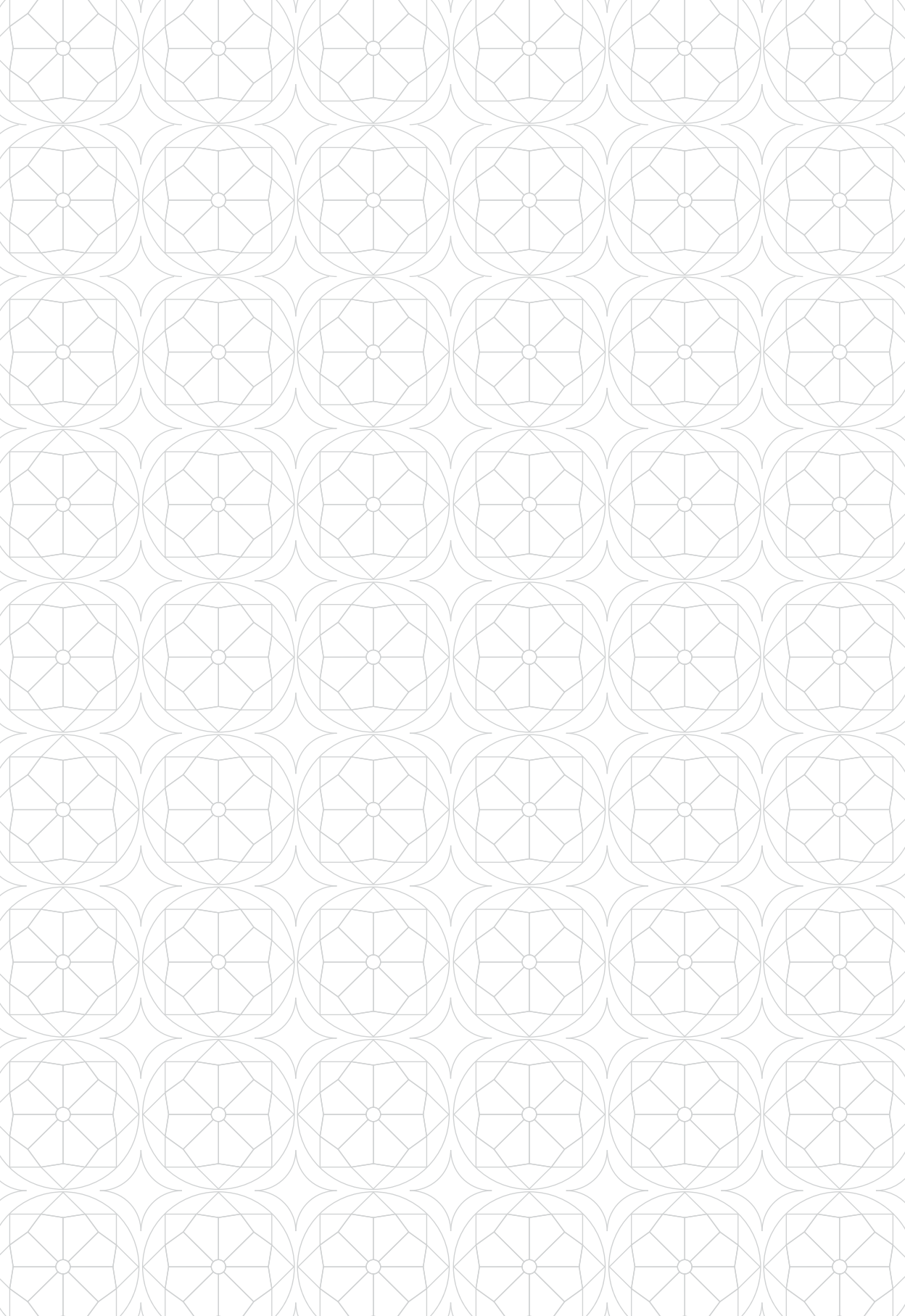

- Chairman of the Executive Council Resolution No. (37) of 2013 concerning the appointment of a member of the Board of Directors of Abu Dhabi Tourism & Culture Authority, and

The term of the Board's membership shall be five renewable years.

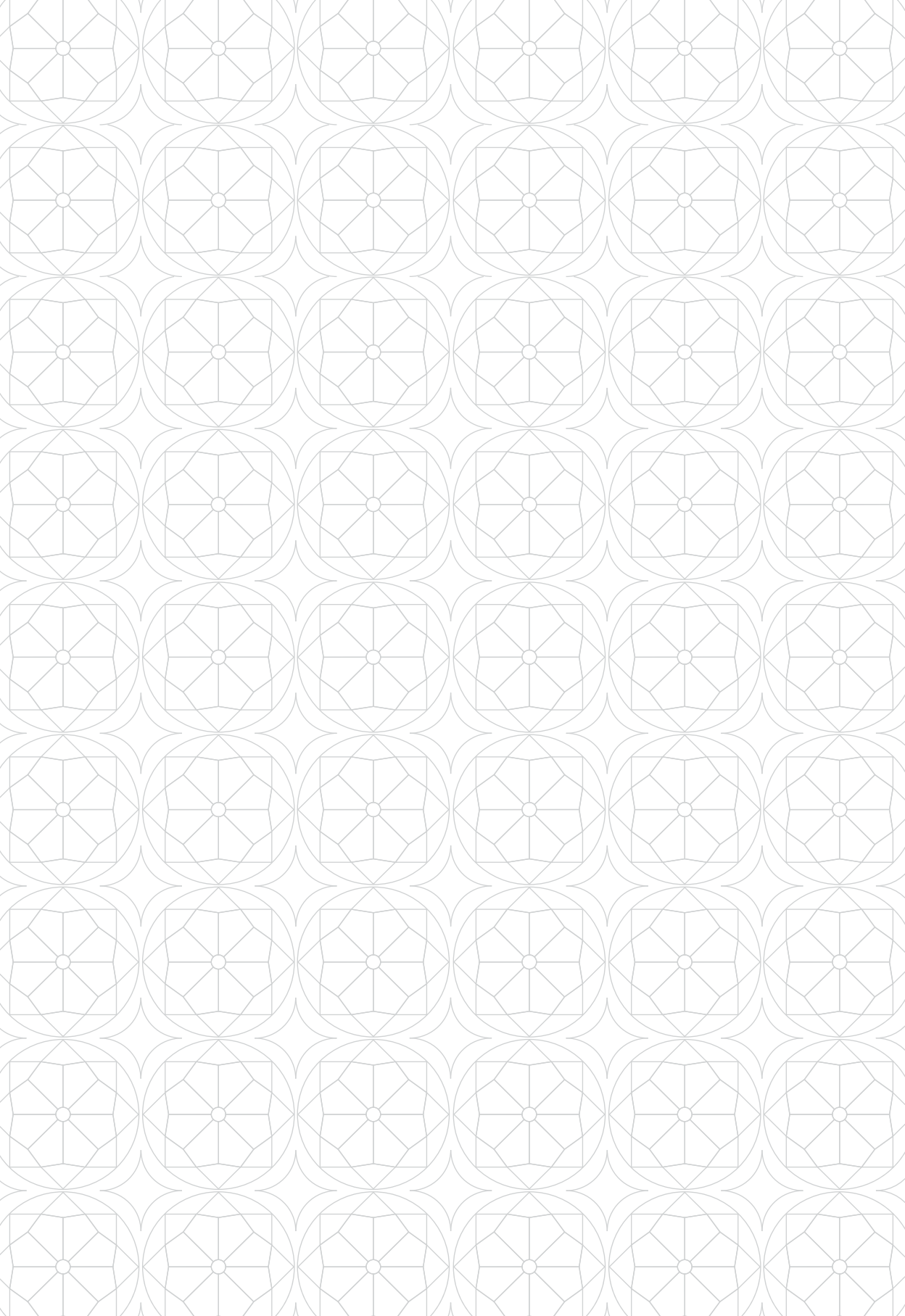
