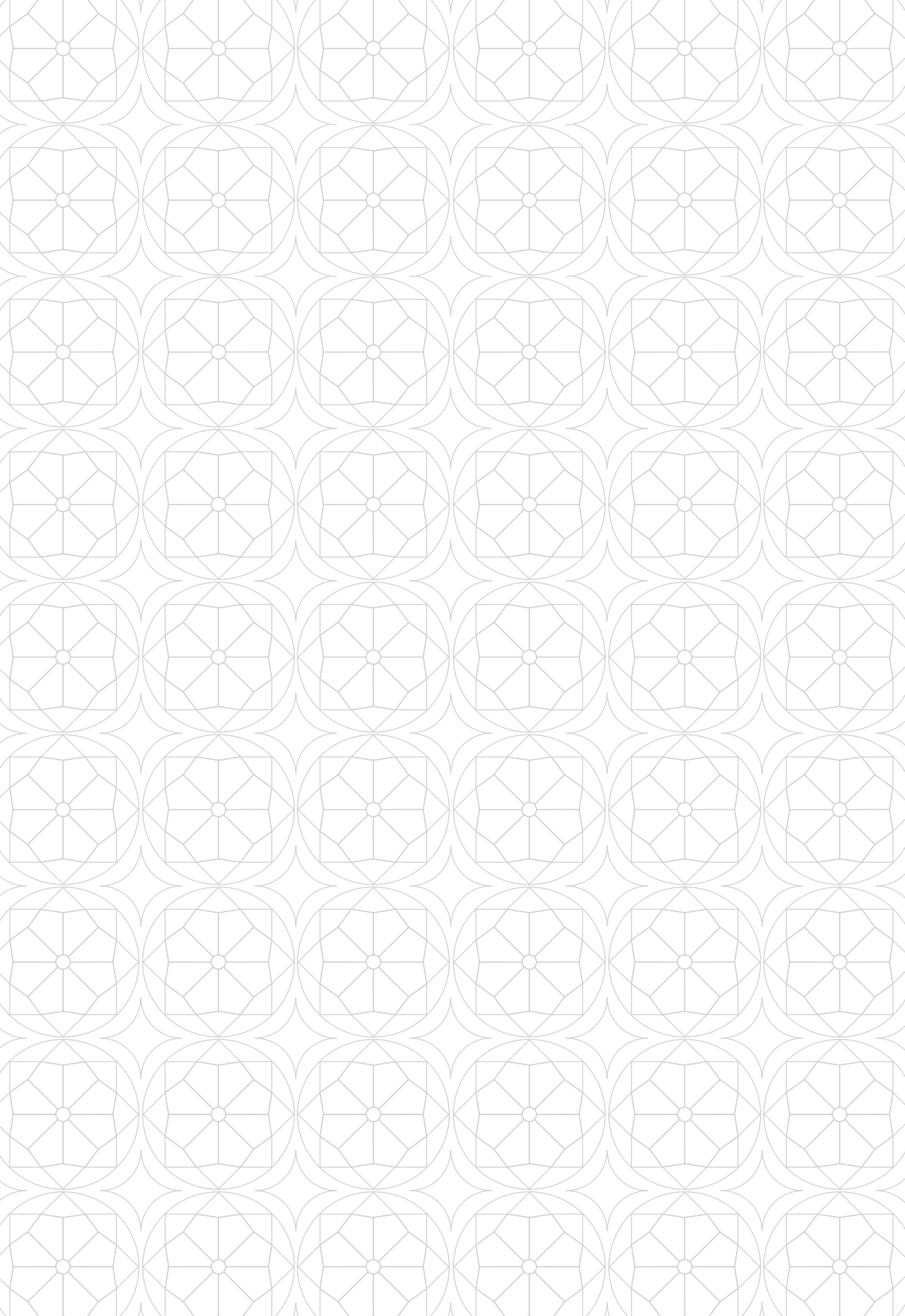

Circular No. (1) of 2016 Concerning the Road Traffic Safety of the Employees in Bad Weather Conditions and Poor Visibility

To all governmental entities and companies in the Emirate of Abu Dhabi

Peace and Allah's mercy and blessings be upon you,

The Executive Council is pleased to greet you and to extend its sincere gratitude for your continuous cooperation to realise the common interest.

In line with the continuous concern for the safety of the employees and in order to prevent road traffic accidents, the necessary regulations, controls, and procedures shall be laid down, so as to ensure the flexibility of attendance and leave systems for the employees in bad weather conditions.

For the purposes of implementation of this Circular, the following guidelines shall be observed:

- Lay down the appropriate internal regulations, controls and procedures which ensure the safety of the employees and maintain the work progress.
- Meet the requirements of occupational safety and health, and human resources internally, in order to support the implementation of the regulations and procedures raised in this regard.
- Coordinate with the concerned entities to be informed of bad weather conditions which may require the alert of employees thereto.

- Communicate with the employees in bad weather conditions using your most appropriate means of communication.
- Raise awareness among employees concerning the importance of avoiding their presence on roads in bad weather and poor visibility conditions.
- Give priority in the implementation of this Circular to the employees who use the external roads.

3. The employees' effective participation in the permanent technical committees and work teams which are formed for the development and introduction of Abu Dhabi technical documents and compliance schemes.

Abu Dhabi Quality and Conformity Council (QCC) shall commit to submit a periodic report every six months to the General-Secretariat of the Executive Council on the extent of participation of the governmental entities and their compliance with the content of this Circular.

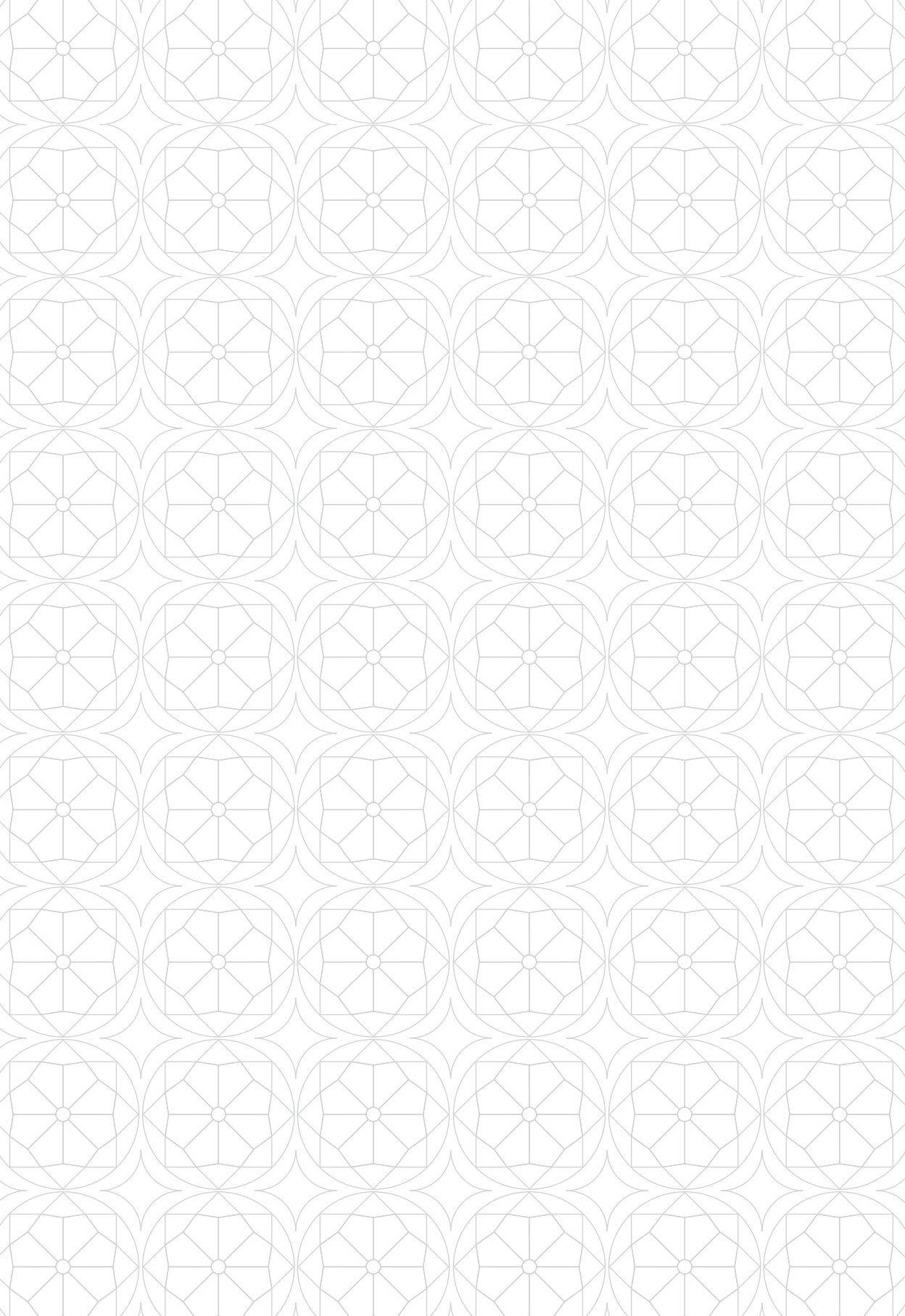
