

Law No. (1) of 2016 Concerning the Amendments of Some Provisions of Law No. (7) of 1977 concerning the Police and Security Forces in the Emirate of Abu Dhabi

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (7) of 1977 concerning the Police and Security Forces in the Emirate of Abu Dhabi, and
- Based on what was presented to and approved by the Executive Council,
 Issued the following Law:

Article (1)

Article (2) of aforesaid Law No. (7) of 1977 shall be replaced by the following:

The following words and phrases shall be replaced, wherever mentioned in Federal Law No. (12) of 1976 concerning the Police and Security Forces, with the words and phrases corresponding thereto, unless the context requires otherwise:

State or Federation : Emirate of Abu Dhabi

Federal Government : Abu Dhabi Government

Council of Ministers : Executive Council of the Emirate of

Abu Dhabi

Ministry or Ministry of Interior : Abu Dhabi Police GHQ

Forces or Police and Security Forces: Abu Dhabi Police GHQ

Minister : Commander-in-Chief of Abu Dhabi

Police

Undersecretary or Undersecretary: Director-General of Abu Dhabi

of the Ministry of Interior Police

Ministers : Chairmen of government entities

Federal Decree : Amiri Decree

Article (2)

Abu Dhabi Police General Headquarters shall have a Commander-in-Chief and a Director-General to be appointed by an Amiri Decrees.

Article (3)

The Commander-in-Chief of Abu Dhabi Police shall assume – within the scope of the Emirate – the competences and powers assumed by the Minister of Interior and any other competences stipulated in Law No. (7) of 1977 concerning the Police and Security Forces in the Emirate of Abu Dhabi or any other legislations.

A resolution shall be issued by the Chairman of the Executive Council on the approval of the schedule of competences and powers stipulated in the previous paragraph for each of the Commander-in-Chief and Director - General of Abu Dhabi Police.

Article (4)

The associate members of Abu Dhabi Police GHQ working at the Ministry of Interior shall be transferred thereto as well as all its assets, contracts, rights, obligations and accounts and all its works, tasks, documents and properties that are present in the Ministry of Interior.

Article (5)

The transfer stipulated in Article (4) of this Law shall be entrusted to a committee that shall be formed by a resolution issued by the Chairman of the Executive Council.

The committee shall submit its recommendations to the Executive Council for approval.

Article (6)

The Executive Council may form committees and work teams and issue the resolutions required for the implementation of this Law.

Article (7)

Any text or provision contrary to the provisions of this Law shall be repealed.





Article (2)

- The lessees of the industrial lands and lands leased out by the government may lease them out to others on condition that an approval is obtained from the concerned Municipality, and provided that all contracts are registered in accordance with the applicable legislations.
- The Department of Municipal Affairs shall collect a registration fee from the lessee equal to 5% of the value of any contract of lease or Musataha of industrial lands and lands leased out by the government.

Article (3)

The aforesaid Executive Council Resolution No. (8) C 23/1979 shall be repealed. Any text or provision to the contrary of the provisions of this Resolution shall be repealed.



This Resolution shall be effective from the date of its issuance.


