Chairman of the Executive Council Resolution No. (37) of 2016 Concerning the Fee for the Use of Airport Facilities in the Emirate of Abu Dhabi

We, Mohamed bin Zayed Al Nahyan, Crown Prince, Chairman of the Executive Council,

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Amiri Decree No. (5) of 2006 concerning the establishment of Abu Dhabi Airports Company "Public Joint Stock Company"; and
- •Based on what was presented to and approved by the Executive Council; Issued the following Resolution:

Article (1)

- Every departing passenger or transit passenger (continuing his journey with the same airline company or any other company) shall pay, when leaving the State through the airports of the Emirate of Abu Dhabi, a fee of AED thirty five (35) for using the airport facilities.
- •Children under the age of two as well as the transit passengers (whose-number of the arrival and departure flights is the same) and the cabin crew on the job, shall be exempt from the fee stipulated in the first paragraph.

•The airline companies operating in the airports of the Emirate of Abu Dhabi -

shall be responsible for collecting the fee stipulated in the first paragraph

of this Article upon issuing the travel tickets to their customers whether

in the United Arab Emirates or abroad, as long as the departure will take

place from the airports of the Emirate of Abu Dhabi on or after the date

of 30/6/2016. These companies shall transfer the proceeds of this fee

to Abu Dhabi Airports Company.

•The proceeds of the fee collected pursuant to the provisions of this -

Resolution shall devolve to Abu Dhabi Airports Company.

Article (2)

This Resolution shall be effective from the date of its issuance and published

in the Official Gazette.

First - Formation of the Governmental Service Development Team:

The team shall be formed under the chairmanship of the Director-General of the entity or the like and the membership of at least the representatives of the following units:

- Customer Service-
- Human Resources-
- Strategy-
- Financial Affairs.
- Legal Affairs.
- Information Systems ·
- Media and Communication Office-
- Digital Transformation Leadership Team.

Functions of the Team:

- The focal point of contact for the improvement and development of services.
- Following up the digital transformation of services and working on the development thereof.
- Simplifying the procedures and reducing the time needed for delivering the services.
- Developing and following up the governmental services performance indicators and submitting suggestions to improve performance.

- Following up the governmental services reports submitted by the General Secretariat of the Executive Council (Mystery Shopper and other)
- Following up the implementation of the guidelines of the governmental services and updating the self-assessment tools thereof (Customer Service Guide and other)
- Studying the internal challenges and laying down service improvement plans, and submitting completion reports to the General Secretariat of the Executive Council.
- Studying the challenges shared with the strategic entities and partners and submitting completion reports to the General Secretariat of the Executive Council.
- Laying down media plans to raise awareness, providing customers with the required information, and consolidating the same in all available channels.
- Following up the building of capabilities of customer service employees and laying down improvement and development plans accordingly.
- Working within the frame of an approach supporting and benefiting from the creativity and innovative ideas in both the governmental and private sectors in order to improve the customer experience and rationalise expenses.
- Following up the requests of the General Secretariat of the Executive Council.
