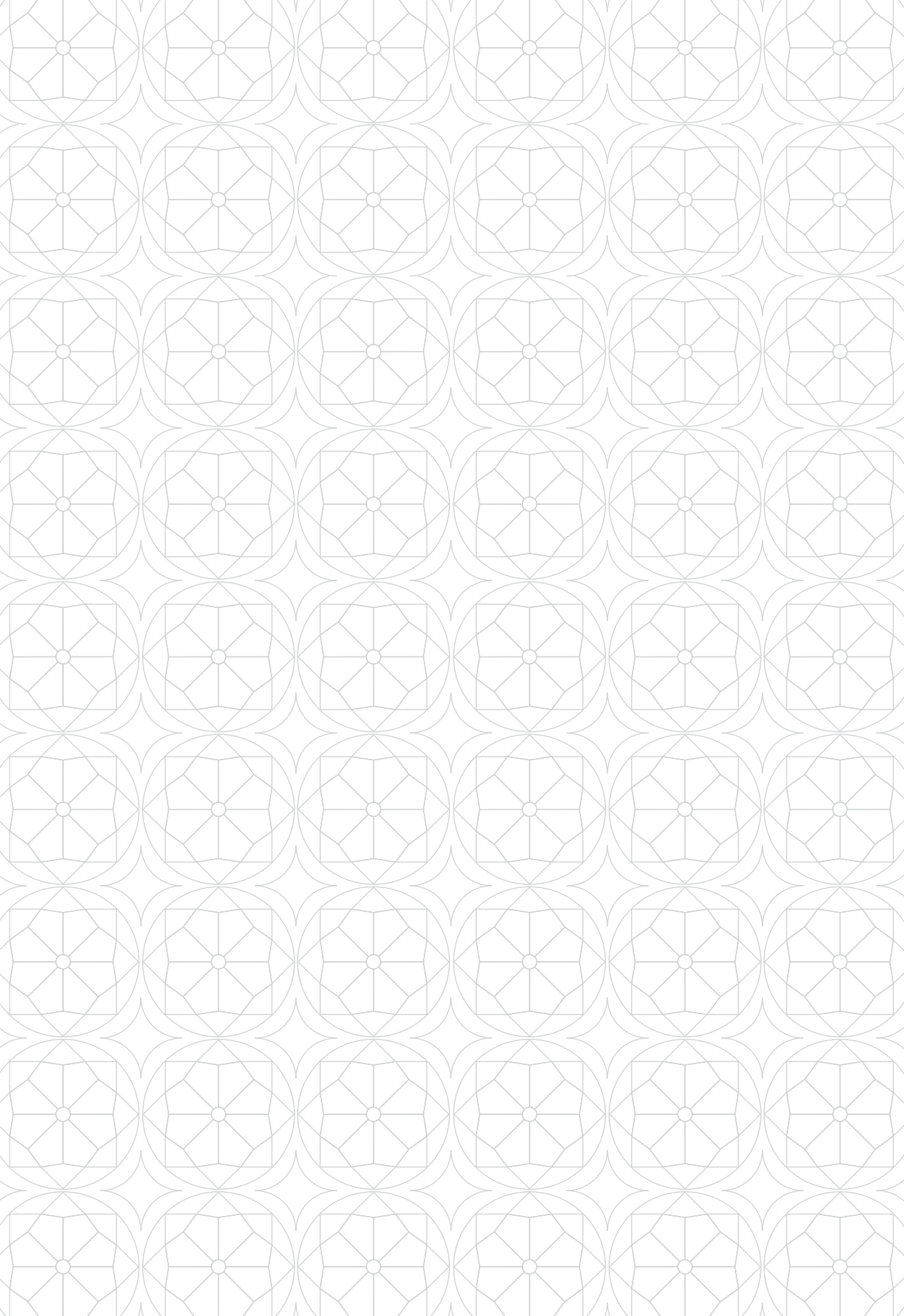

This Law shall be effective from the date of its issuance and published in the Official Gazette.

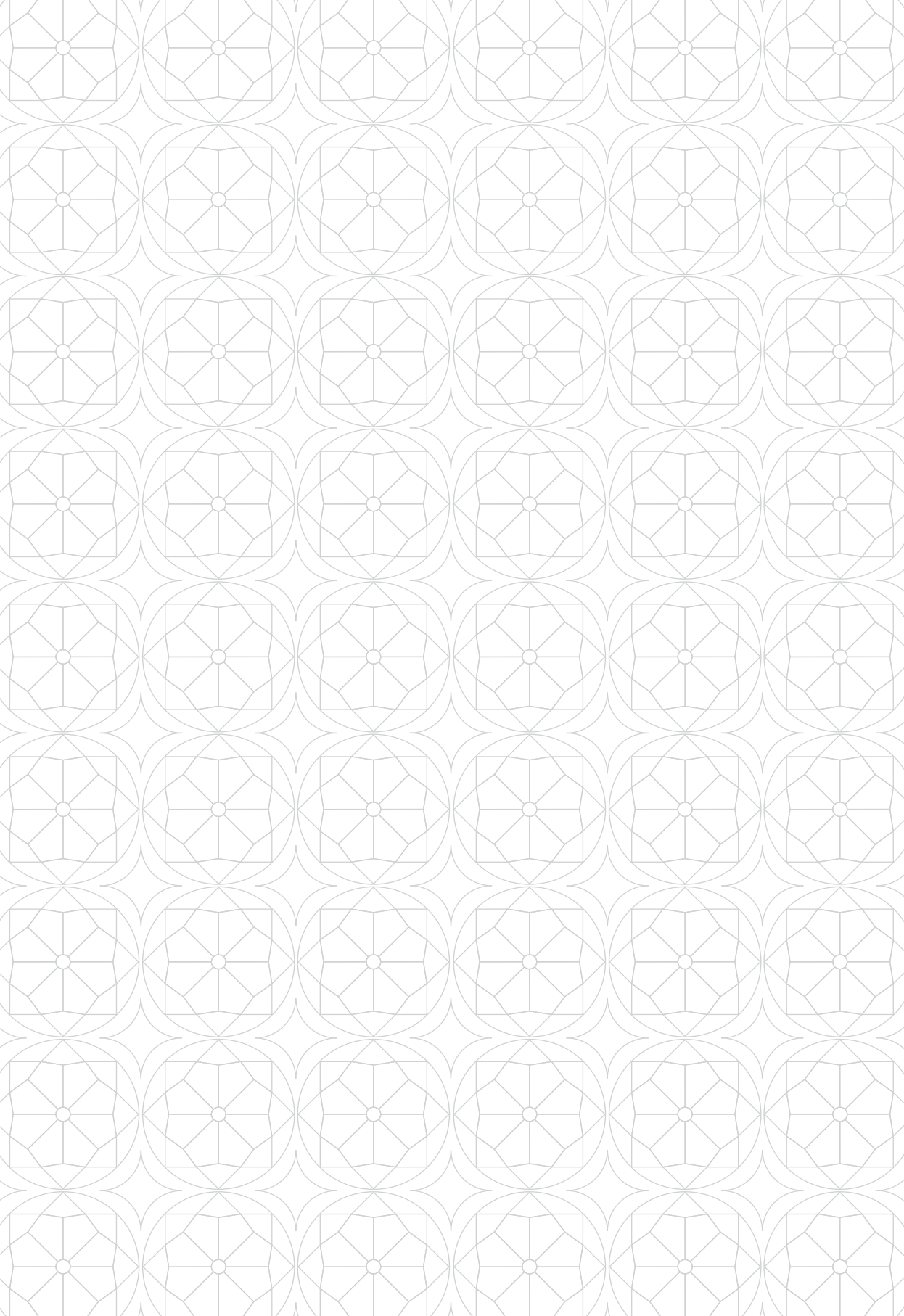
