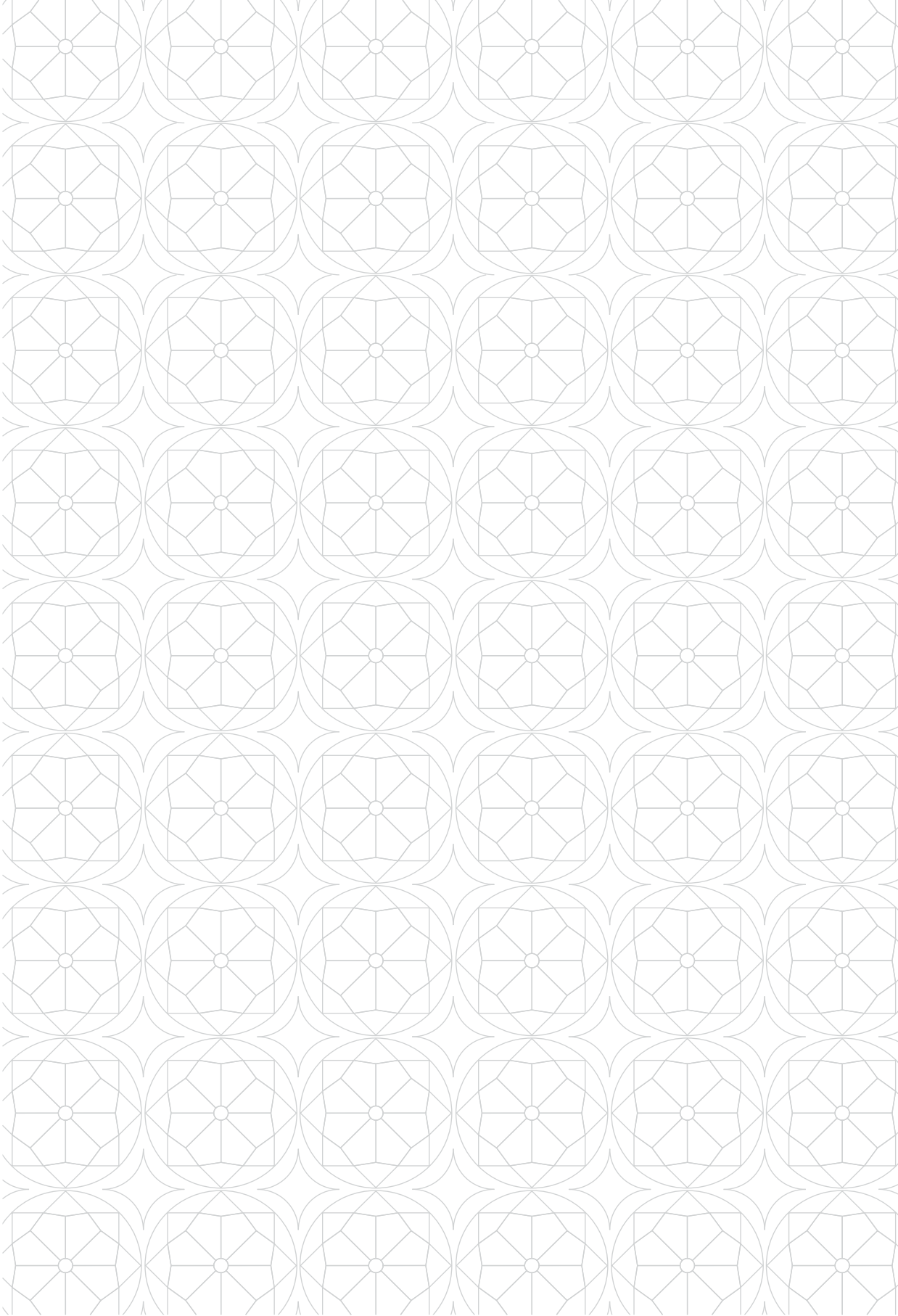

Law No. (6) of 2017 Concerning the Amendment of  
Some Provisions of Law No. (28) of 2007 concerning  
the Reorganisation of the Zoo and Aquarium  
Public Institution in Al Ain

**We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi,**

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (28) of 2007 concerning the reorganisation of the Zoo and Aquarium Public Institution in Al Ain; and
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

Article (1)

Article (5) of the aforesaid Law No. (28) of 2007 shall be replaced by the following:

- The Institution shall be managed by a Board of Directors consisting of at least five members, including the Chairman, whose appointment and remuneration are determined by a Chairman of the Executive Council resolution.

- The term of the Board's membership shall be three renewable years.
- The internal regulations shall determine the procedures for convening the Board meeting and how to vote on its decisions.

#### Article (2)

A new clause shall be added to Article (8) of the aforesaid Law No. (28) of 2007 as follows:

“Represent the Institution before courts and others, and he may delegate other persons for this purpose.”

#### Article (3)

Article (7) of the aforesaid Law No. (28) of 2007 shall be repealed.

#### Article (4)

This Law shall be effective from the date of its issuance and shall be published in the Official Gazette.

- Law No. (11) of 2007 concerning Al Ain City Municipality and Municipal Council in the Emirate of Abu Dhabi as amended by Law No. (12) of 2016;
- Law No. (13) of 2016 concerning the establishment of the Department of Municipal Affairs and Transport;
- Amiri Decree No. (20) of 2006 concerning the reorganisation of the Ruler's Representative Courts in the Eastern and Western Regions; and
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

## Article (1)

The name of the “Eastern Region” in the Emirate of Abu Dhabi shall be amended to “Al Ain Region” wherever mentioned in the applicable legislations.

## Article (2)

The name of the “Western Region” in the Emirate of Abu Dhabi shall be amended to “Al Dhafra Region” wherever mentioned in the applicable legislations.

## Article (3)

Any provision contrary to the provisions of this Law shall be repealed.

## Article (4)

This Law shall be effective from the date of its issuance and shall be published in the Official Gazette.

Issued the following Law:

## Article (1)

The assets and rights and obligations that were transferred to Abu Dhabi Investment Council pursuant to the aforesaid Law No. (17) of 2016 shall be transferred to the Department of Finance, except for the ownership of shares of Abu Dhabi National Energy Company that shall be transferred to Abu Dhabi Water and Electricity Authority.

## Article (2)

Any provision contrary to the provisions of this Law shall be repealed.

### Article (3)

This Law shall be effective from the date of its issuance and shall be published in the Official Gazette.

# Law No. (9) of 2017 Concerning Fishing Cooperative Associations in the Emirate of Abu Dhabi

**We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi,**

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (16) of 2005 concerning the reorganisation of the Environment Agency - Abu Dhabi as amended by Law No. (5) of 2009;
- Law No. (2) of 2009 concerning the establishment of the Economic Development Department;
- Federal Law No. (1) of 1972 concerning the Competences of the Ministries and Powers of the Ministers and its amendments;
- Federal Law No. (13) of 1976 concerning Cooperative Associations;
- Federal Law No. (23) of 1999 concerning the Exploitation, Protection and Development of the Living Aquatic Resources in the United Arab Emirates as amended by Federal Law No. (7) of 2016; and
- Based on what was presented to and approved by the Executive Council,



Issued the following Law:

Article (1)

In the implementation of the provisions of this law, the following words and phrases shall have the meanings corresponding thereto unless the context requires otherwise:

Emirate	: The Emirate of Abu Dhabi.
Executive Council	: The Executive Council of the Emirate.
Cooperative Association	: Any cooperative association established according to the provisions of the laws enforced in the Country and whose objective is fishing or the conservation and development of fish wealth inside the Emirate.

Article (2)

This Law aims at regulating the work of the cooperative associations which are operating in the fishing field or the fishermen cooperative societies in order to guarantee the conservation and development of fish wealth inside the Emirate as well as profits to the members of the said associations.

Article (3)

No cooperative society or any branch thereof may commence any fishing activity inside the Emirate before obtaining a licence from the Environment Agency - Abu Dhabi.

#### Article (4)

The Chairman of the Economic Development Department shall issue, following the approval of the Executive Council, the regulations and resolutions related to the management of the fishing cooperative associations as well as the conditions and controls of their membership and the membership of their boards of directors, the control and supervision of their works, the books or records to be kept, the list of administrative penalties that may be imposed on the society, its board of directors or any member of the society or its board of directors, and the merger of the cooperative associations or dissolution thereof for the public interest requirements, so as to ensure the contribution of said associations in the implementation of the economic and social plans of the Emirate, the maintenance of the members' rights, and compliance with the laws, rules and regulations applicable.

#### Article (5)

The cooperative associations that practice their activity in the Emirate and existing at the time of the issuance of this Law shall adjust their situation in accordance with its provisions, within 30 days from the date of its publication in the Official Gazette.

#### Article (6)

Without prejudice to the right of the Executive Council to take any procedures for the administrative closure of the main office of the cooperative association or any branch thereof, any cooperative association that fails to adjust its situation in accordance with the provisions of this Law or the regulations and resolutions issued in implementation thereof, or commences any activity in the

Emirate without obtaining the licence required or in violation of its condition shall be punished by a fine of not less than AED fifty thousand (50,000) and not more than AED Five Hundred Thousand (500,000).

Article (7)

This Law shall be published in the Official Gazette and shall be effective from the date of its publication.

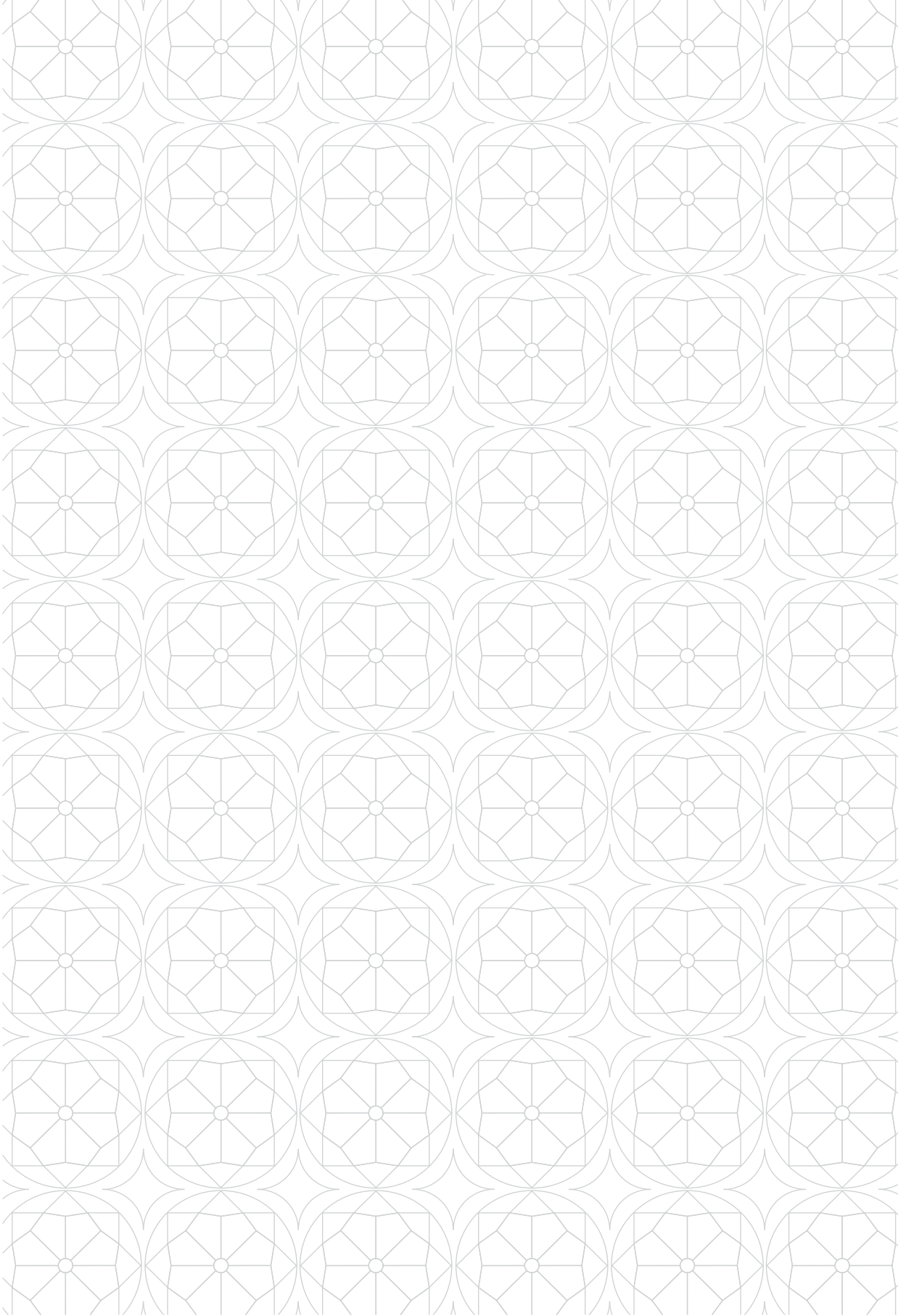

4. This Resolution shall be effective one month after the date of its publication in the Official Gazette.

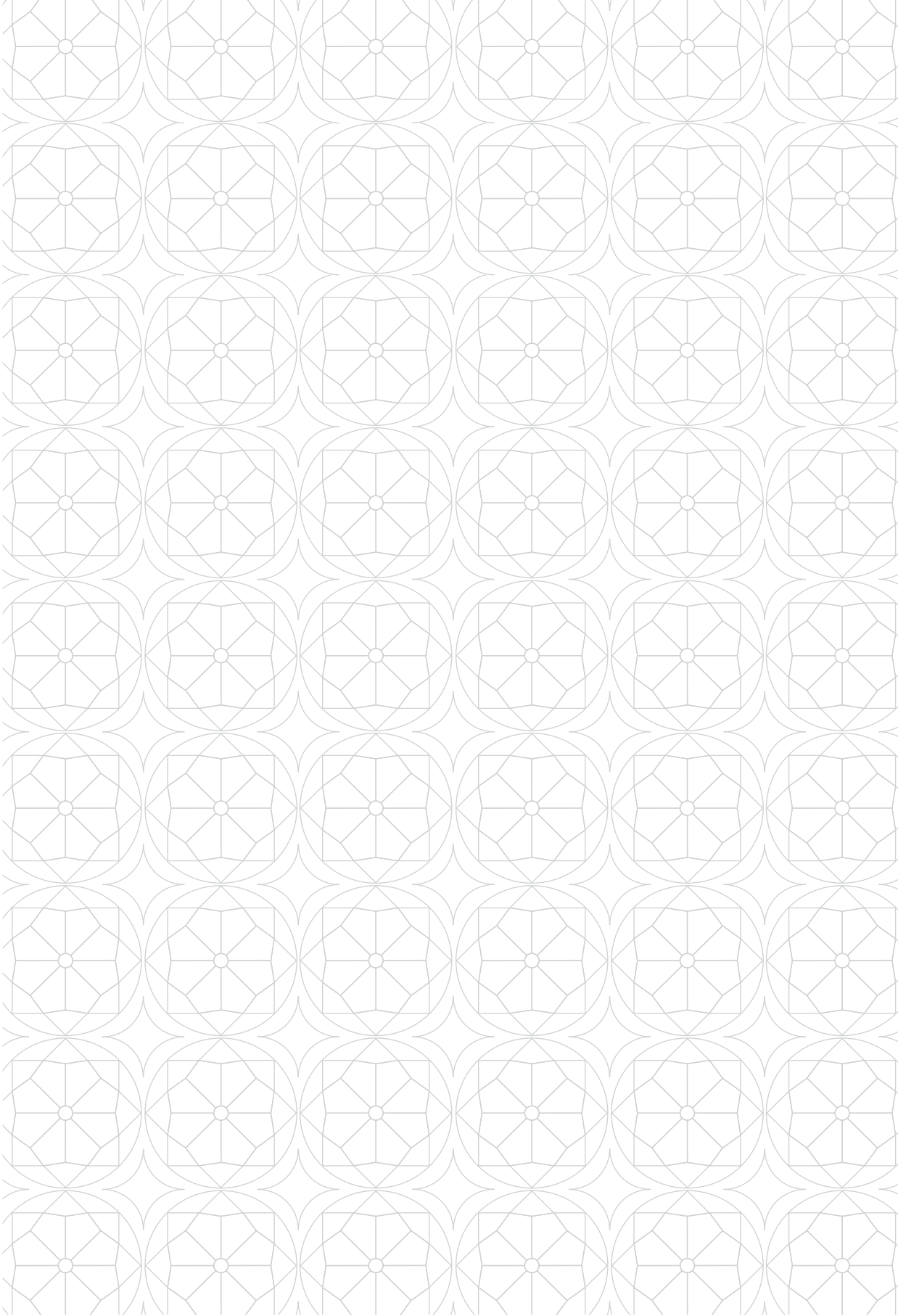

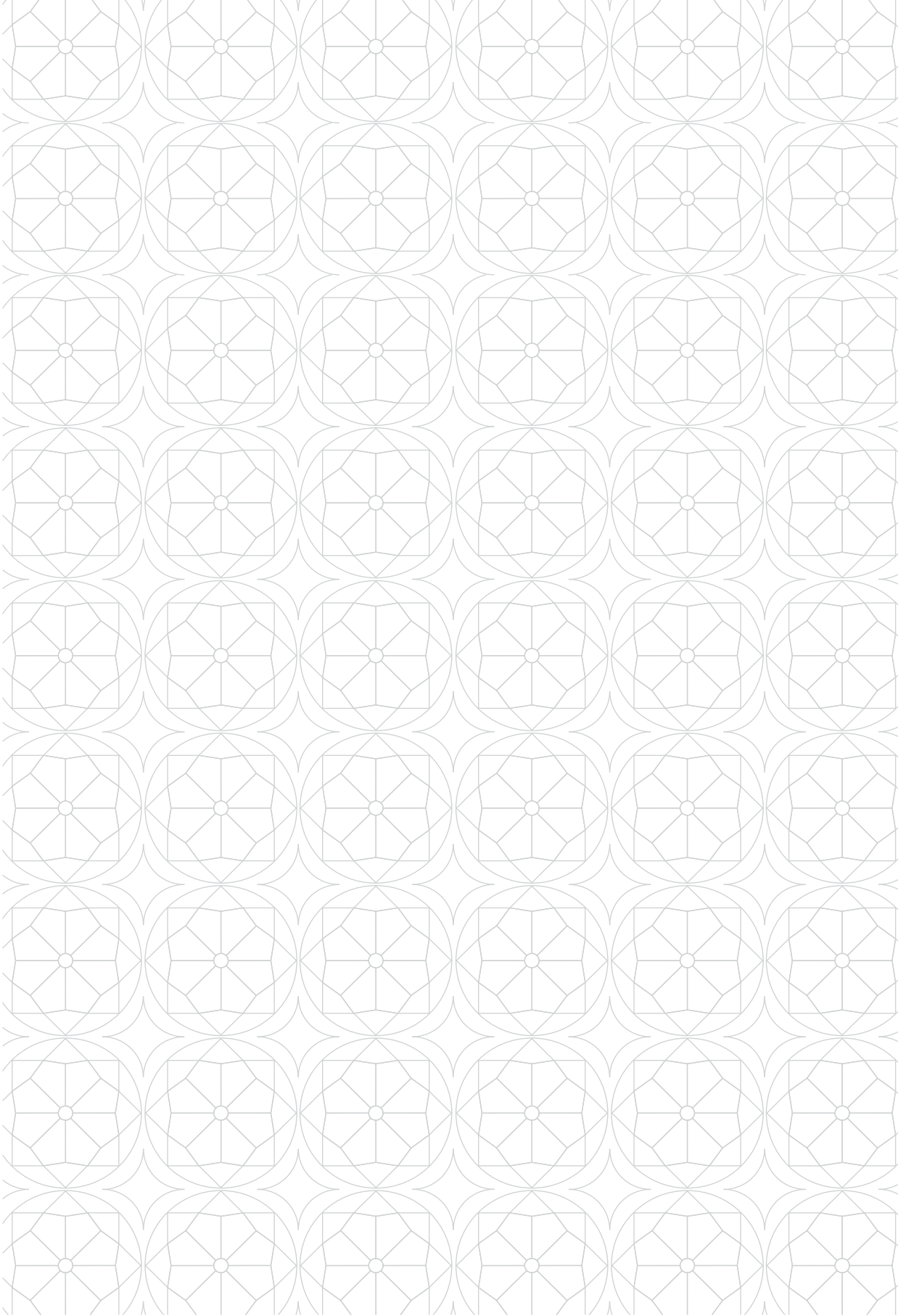

# Circular No. (5) of 2017 Concerning the National Information Security Standards

## **To all governmental companies in the Emirate of Abu Dhabi**

Peace and Allah's mercy and blessings be upon you,

We are pleased to greet you and to extend our sincere gratitude for your continuous cooperation to realise the public interest.

In order to achieve the government's objectives with respect to information security and ensuring the protection required for the infrastructure of the vital governmental information in the Emirate of Abu Dhabi commensurate with the national policies, standards and frameworks, the following shall be observed:

1. Implement the national information security policies, standards and frameworks issued by the National Electronic Security Authority.
2. Consider the second version of the Information Security Policy and Standards of Abu Dhabi Government as a reference manual in the field of information security.
3. Develop specific action plans for the implementation of the national information security standards with the mandated requirements, in cooperation with Abu Dhabi Systems and Information Centre, and submit periodic reports thereto on the work progress.
4. Prepare and implement risk assessment and management plans and prepare and submit periodic reports to Abu Dhabi Systems and Information Centre concerning the level of achievement in accordance with the National Cyber Risk Management Framework issued by the National Electronic Security Authority.

In order to achieve this, Abu Dhabi Systems and Information Centre will assume the following:

- a • Issue complementary standards to the national information security standards, if needed.
- b • Coordinate with the governmental companies to introduce them to the mechanism of action and guidelines required for the implementation of the provisions of this Circular.
- c • Submit periodic reports on the performance of the governmental companies in the implementation of the provisions of this Circular to the Executive Council
