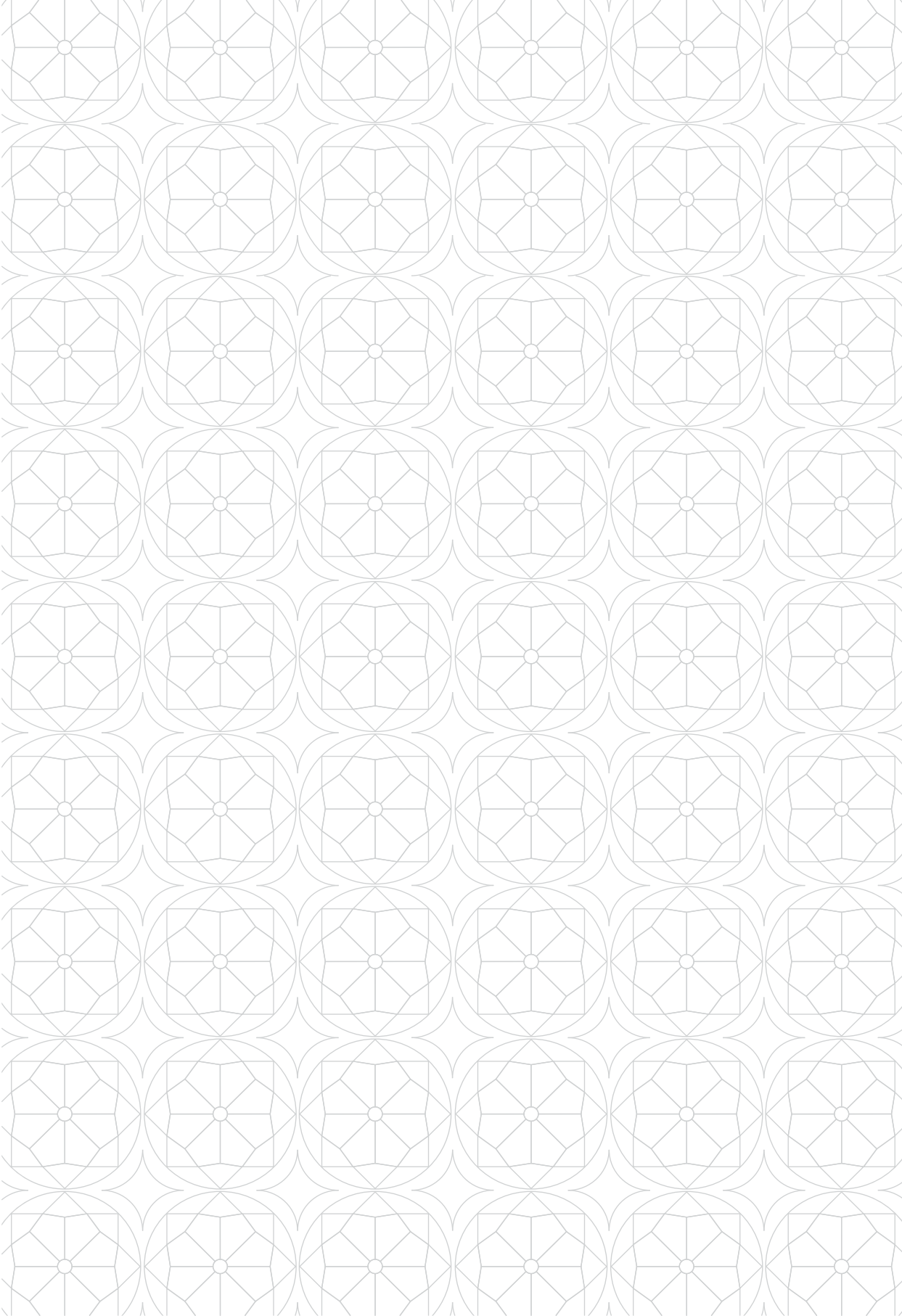

Law No. (10) of 2017 Concerning
the amendment of some Provisions of Law No. (18)

National Exhibitions Company (ADNEC)

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi

Having reviewed:

- Law No. (1) of 1974 concerning the reorganisation of the Governmental body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Advisory Council and its amendments;
- Law No. (18) of 2005 concerning the establishment of Abu Dhabi National Exhibitions Company (ADNEC) and its amendments; and
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

Article (1)

Article (7) of aforesaid Law No. (18) of 2005 shall be replaced as follows:

The Chairman of the Board of Directors shall be the legal representative of the Company before the courts and others, and may delegate whomever he sees appropriate from among the members of the Board of Directors to assume some of his competences.

Article (2)

This Law shall be effective from the date of its issuance and shall be published in the Official Gazette.

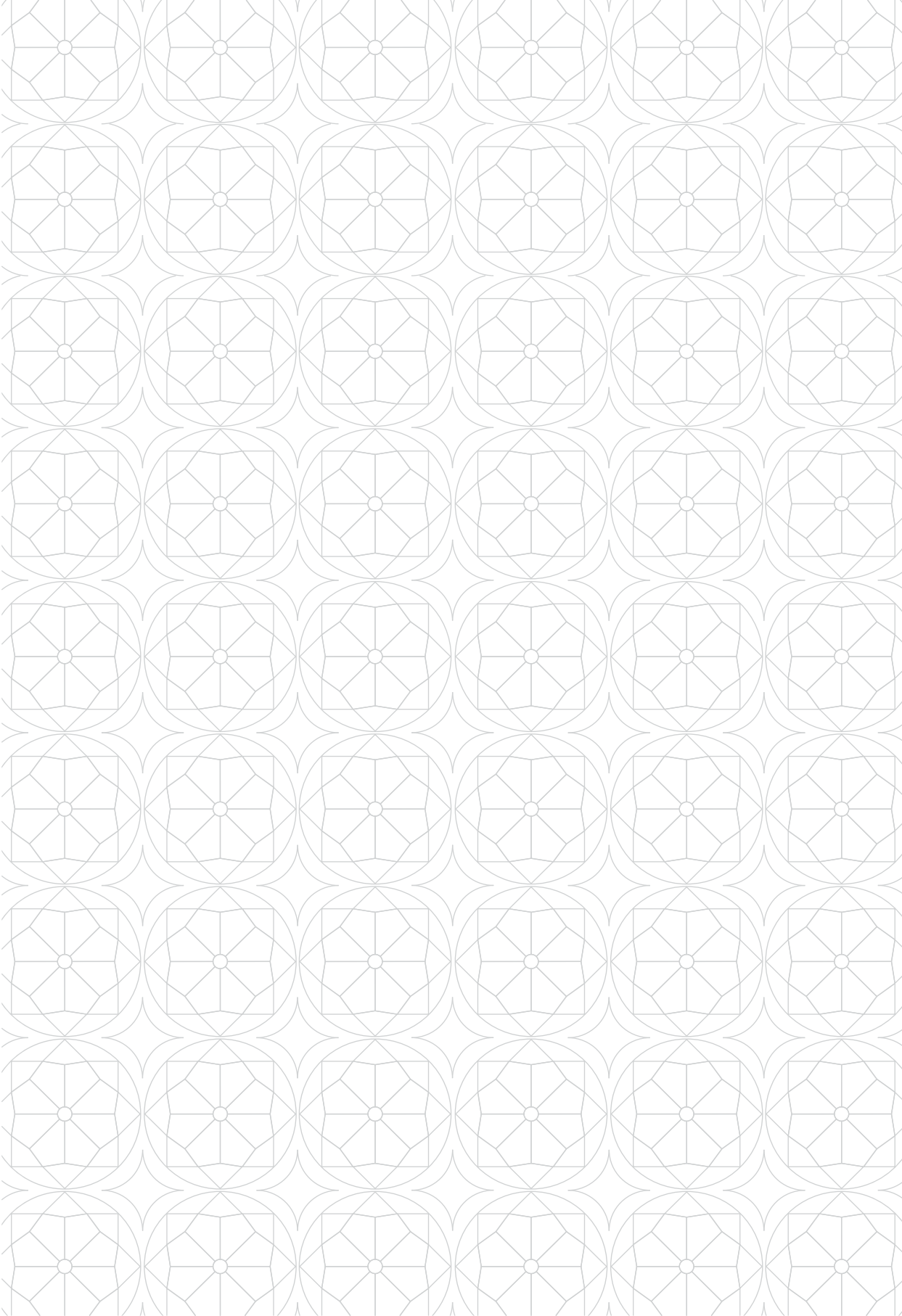

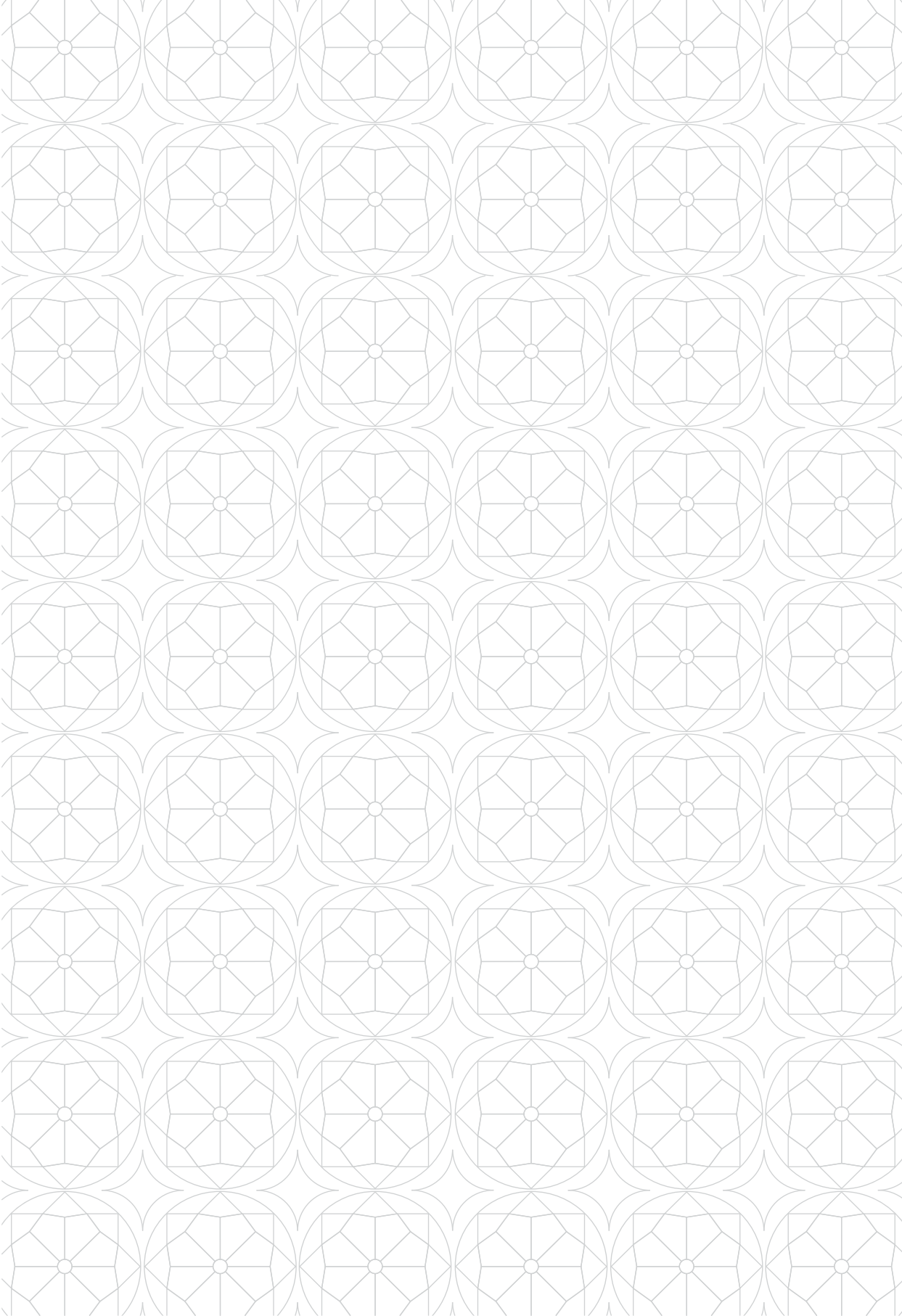

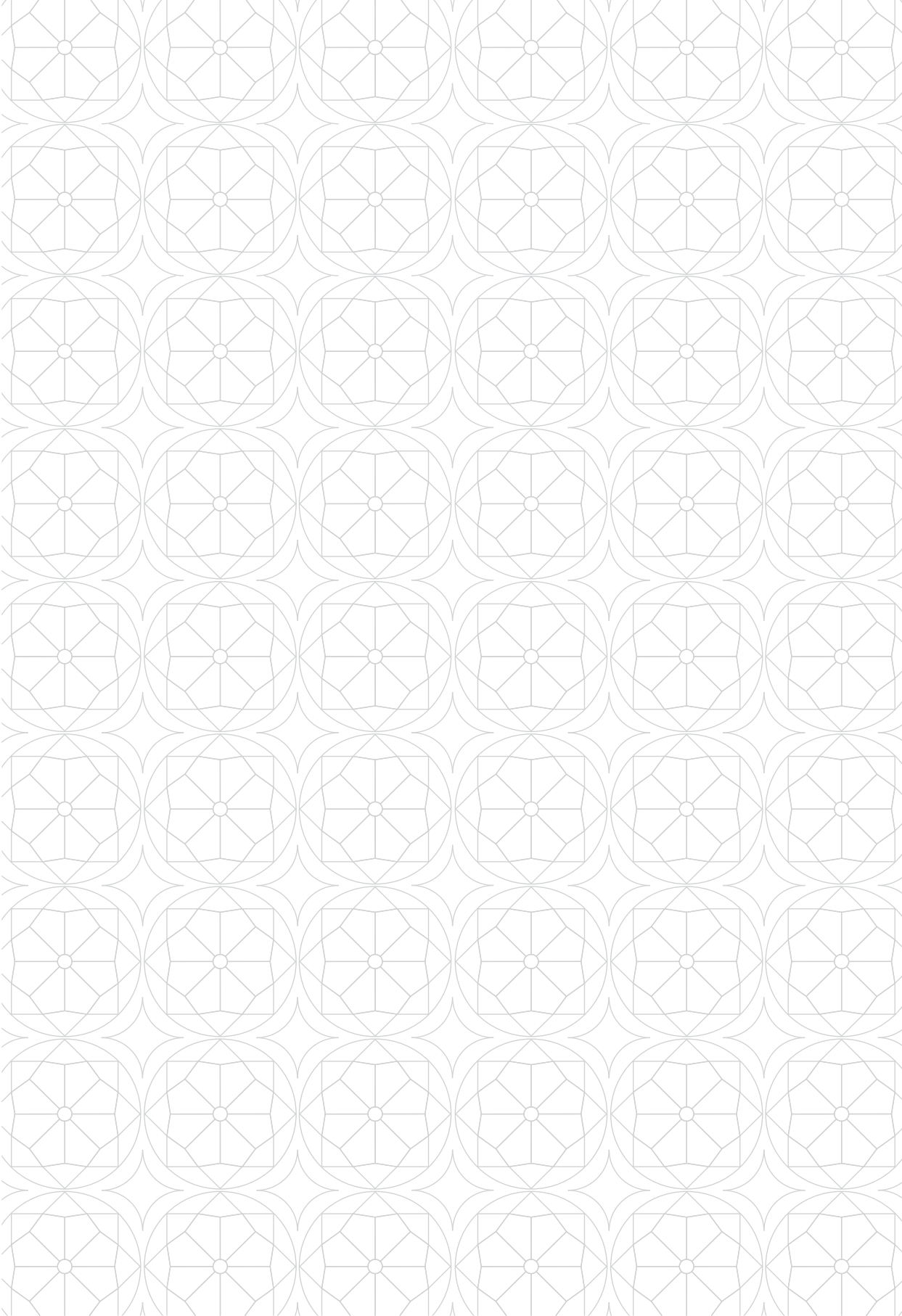

Executive Council Resolution No. (52) of 2017 Concerning Health Insurance for Nationals and the Like in the Emirate of Abu Dhabi

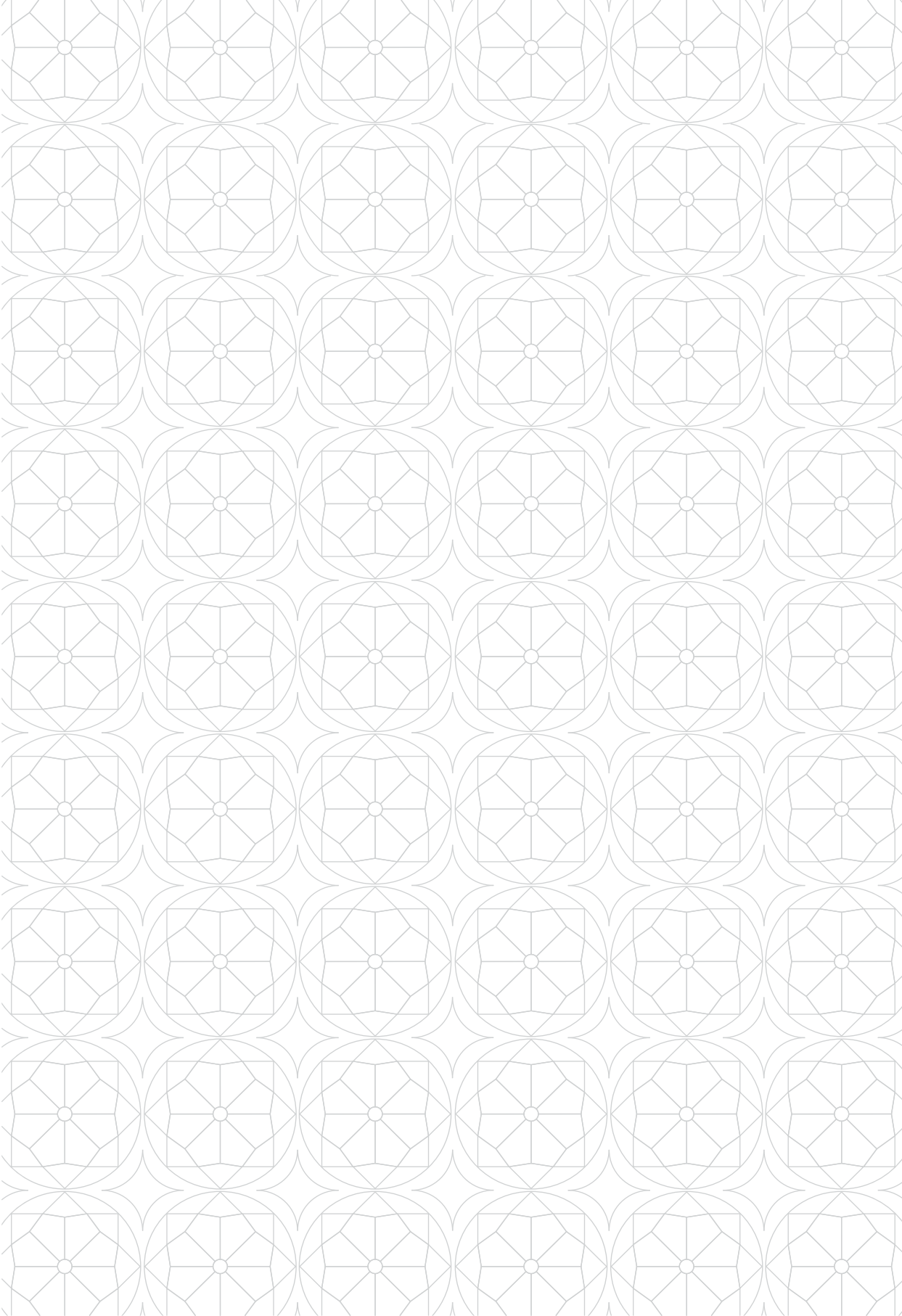
The Executive Council decided the following:

1. The cancellation of Clause (3) of Article (1) of the Chairman of the Executive Council Resolution No. (70) of 2016 concerning the amendment of some provisions of the Chairman of the Executive Council Resolution No. (83) of 2007 concerning the application of the health insurance to the Nationals and the like in the Emirate of Abu Dhabi.
2. This Resolution shall be implemented from the date of its issuance and shall be applied to medical cases at health services providers in the private sector, which originated before its issuance and continued after its effective date, unless the financial claims related to such conditions were settled before the issuance of the present Resolution.

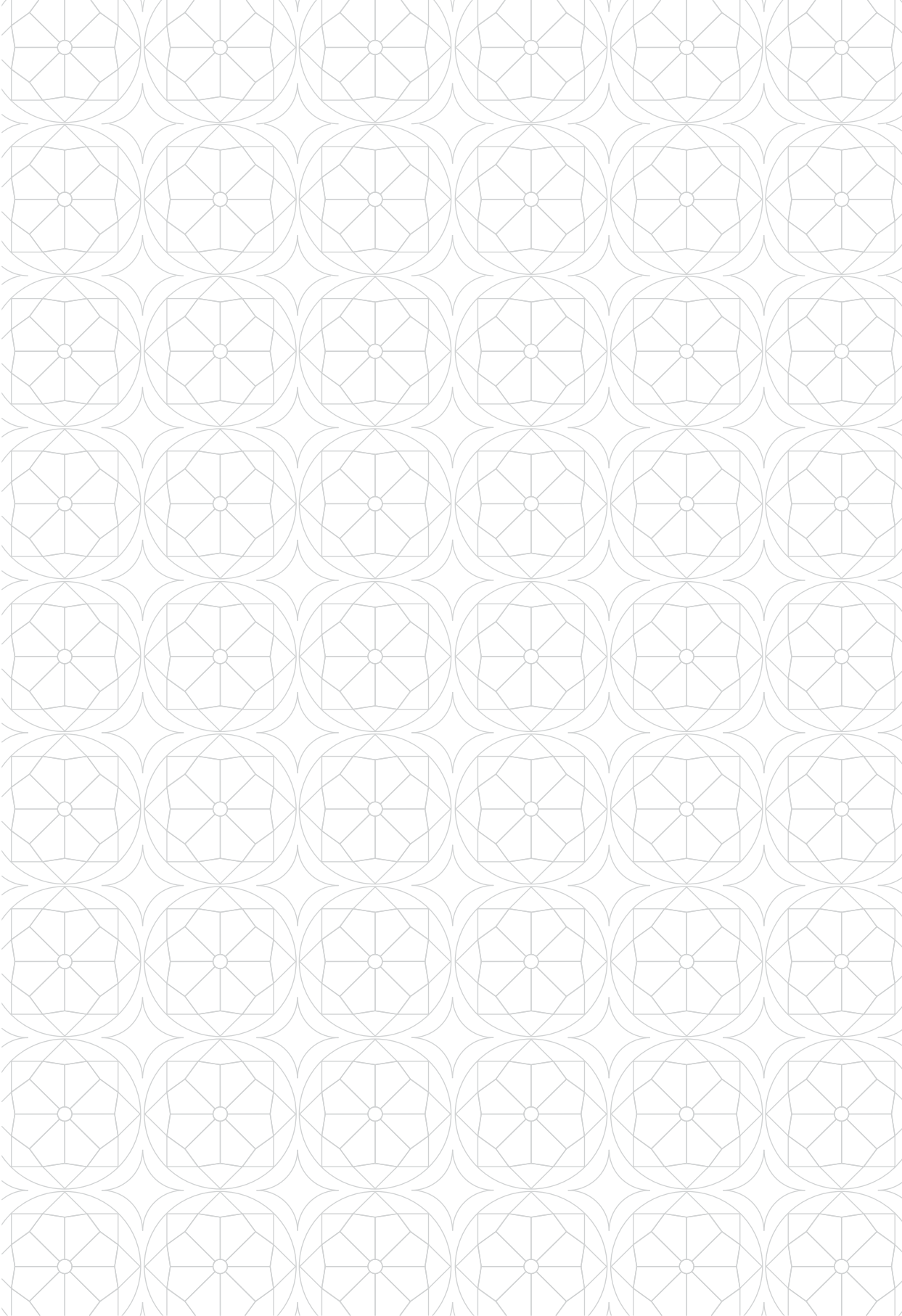
