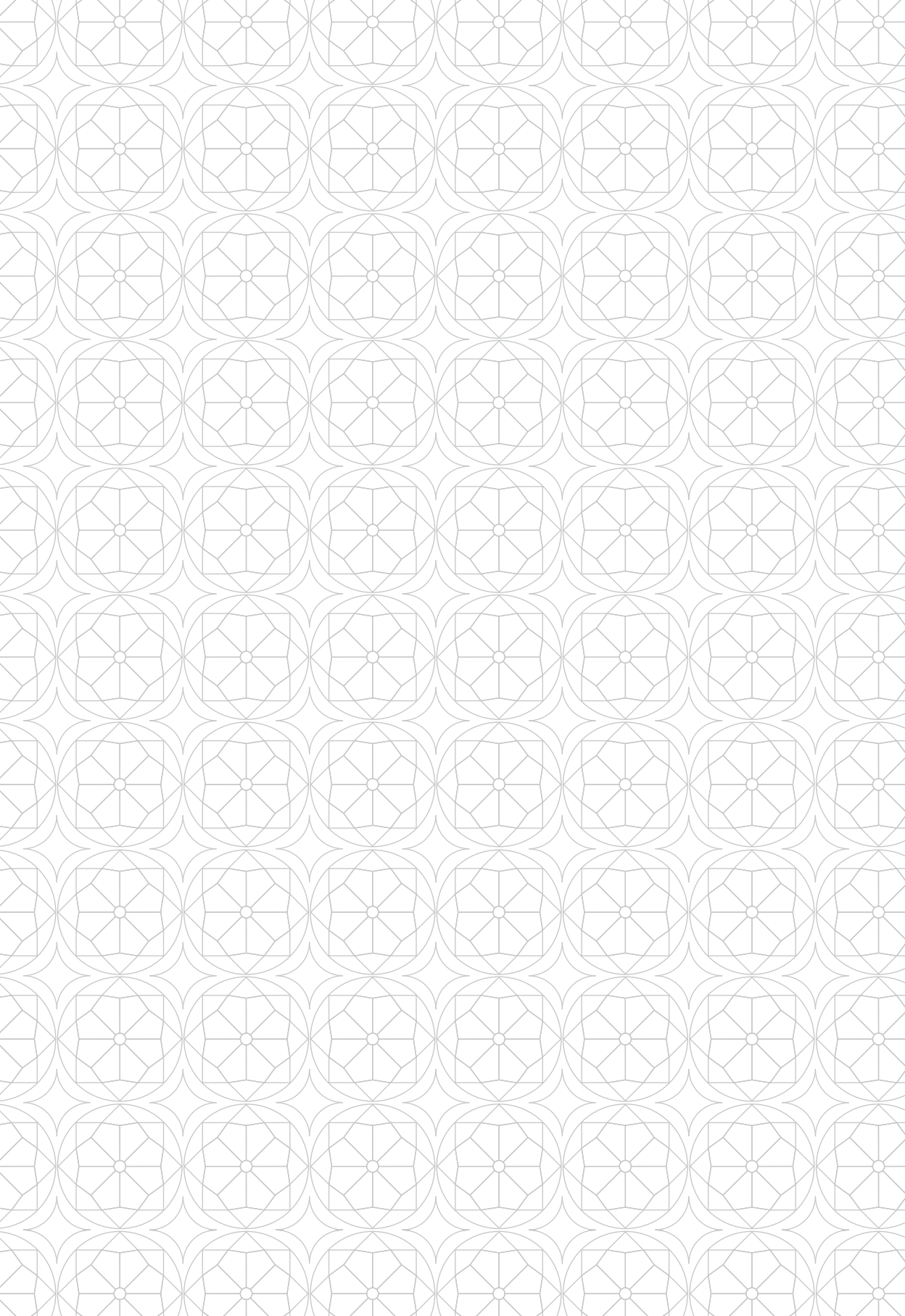

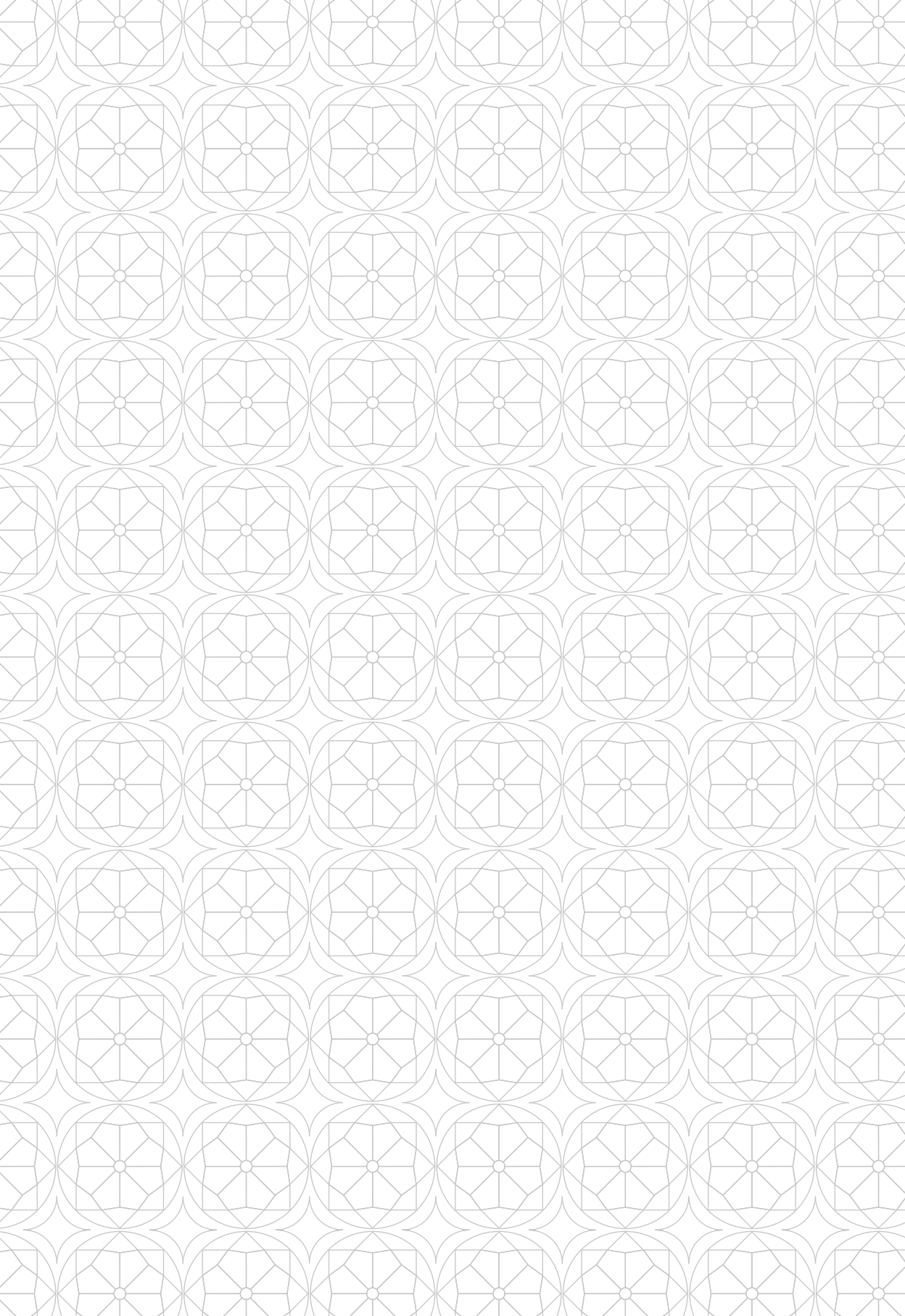

Concerning the Amendment of Some Provisions of
Law No. (16) of 2005 Concerning the Reorganisation
of the Environment Agency – Abu Dhabi

We, Khalifa bin Zayed Al Nahyan, Ruler of Abu Dhabi

Having reviewed:

- Law No. (1) of 1974 concerning the Reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (2) of 1971 concerning the National Consultative Council and its amendments;
- Law No. (16) of 2005 concerning the Reorganisation of the Environment Agency – Abu Dhabi and its amendments; and
- Based on what was presented to and approved by the Executive Council,

Issued the following Law:

Article (1)

The text of Article (4) of the aforesaid Law No. (16) of 2005 shall be replaced by the following text:

Article (4):

- The Agency shall be managed by a Board of Directors consisting of at least five members including the Chairman, who shall be appointed by a Chairman of the Executive Council Resolution.
- The Term of the Board's membership shall be three renewable years.

- The remuneration of the Board members shall be determined by a resolution of the Executive Council.
- The Secretary-General of the Agency shall be appointed in accordance with the applicable legislations.

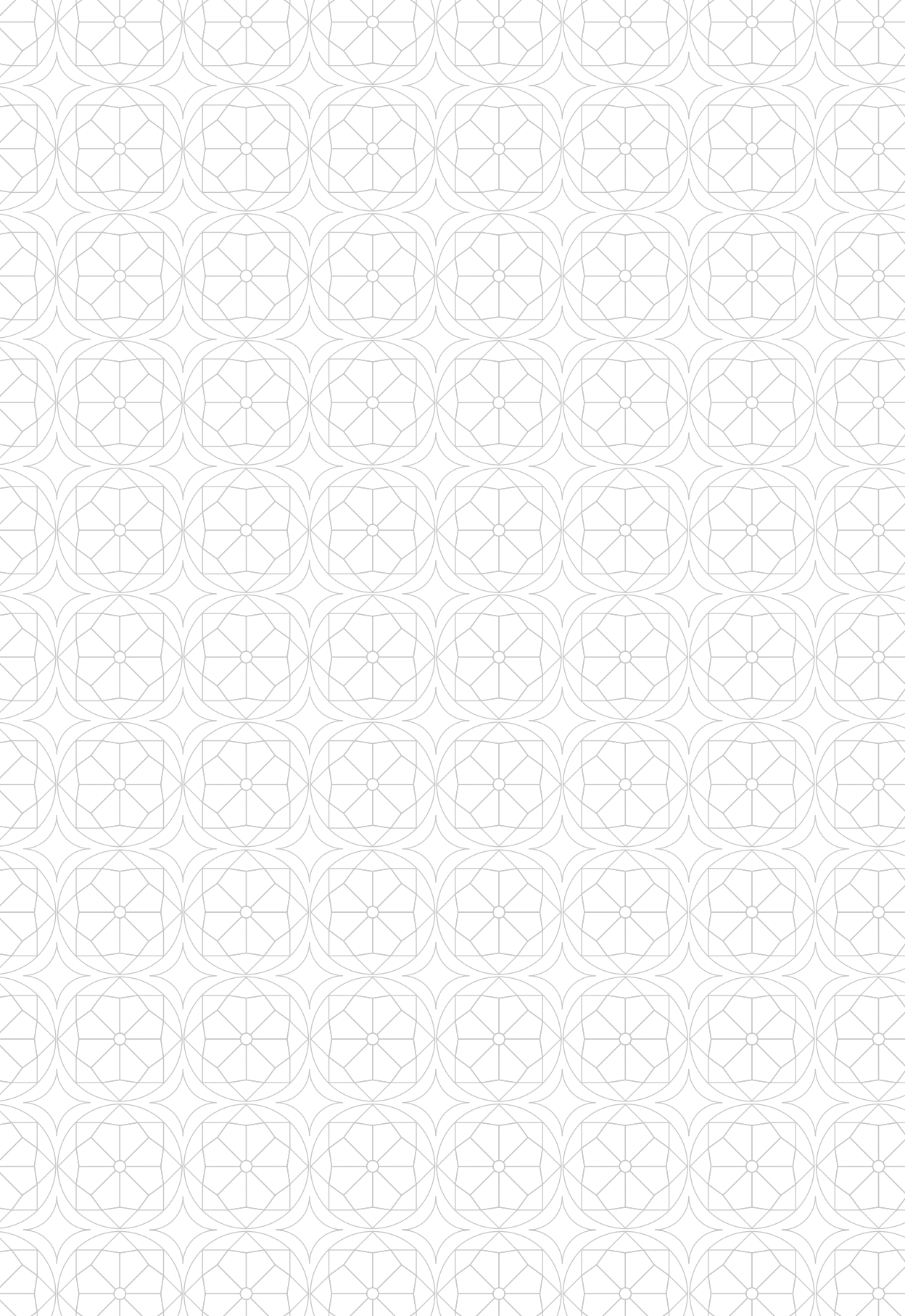
