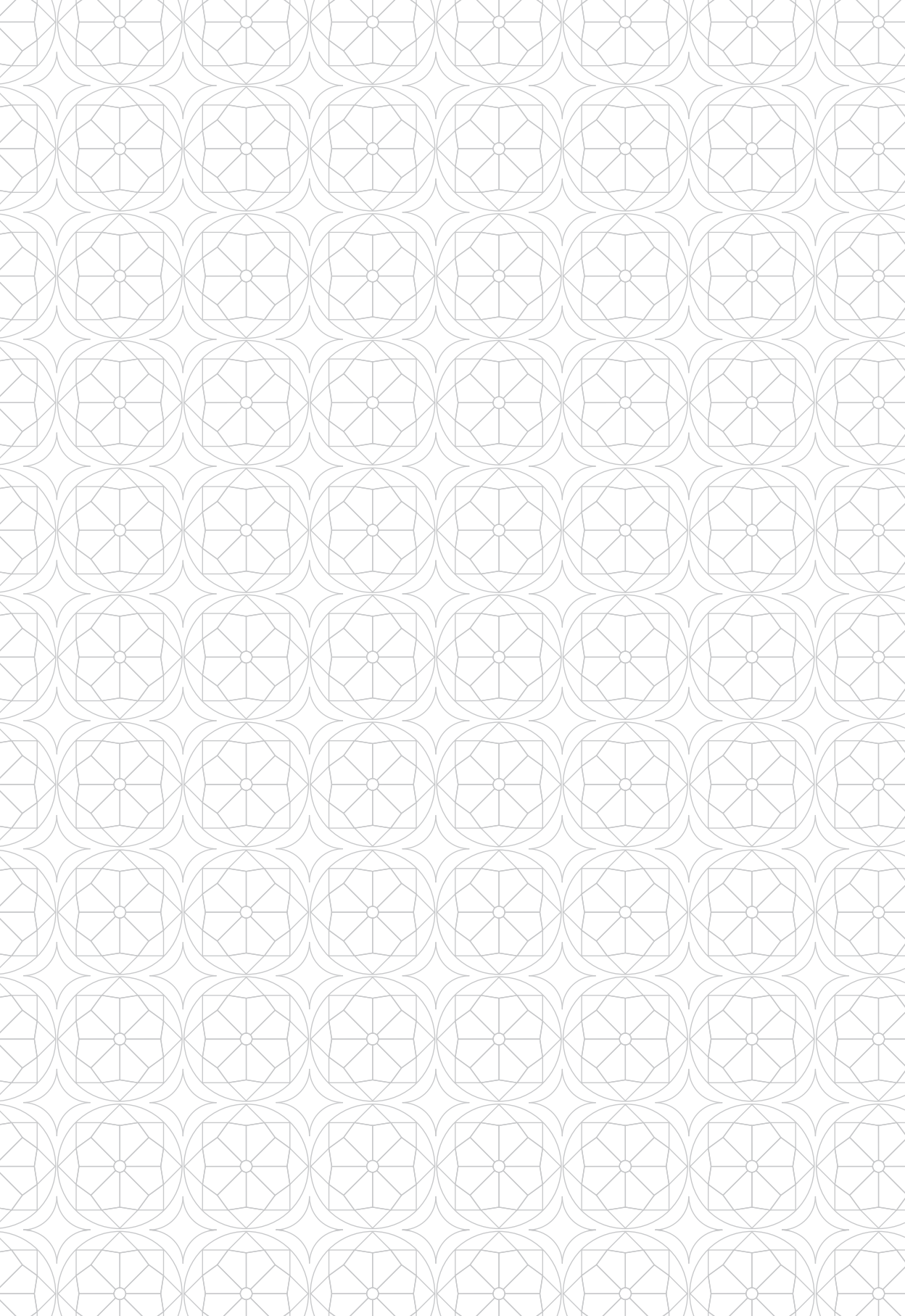

The previous circulars No. (20) of 2014 and (22) of 2016 concerning the Capital Projects Follow-Up System shall be repealed.

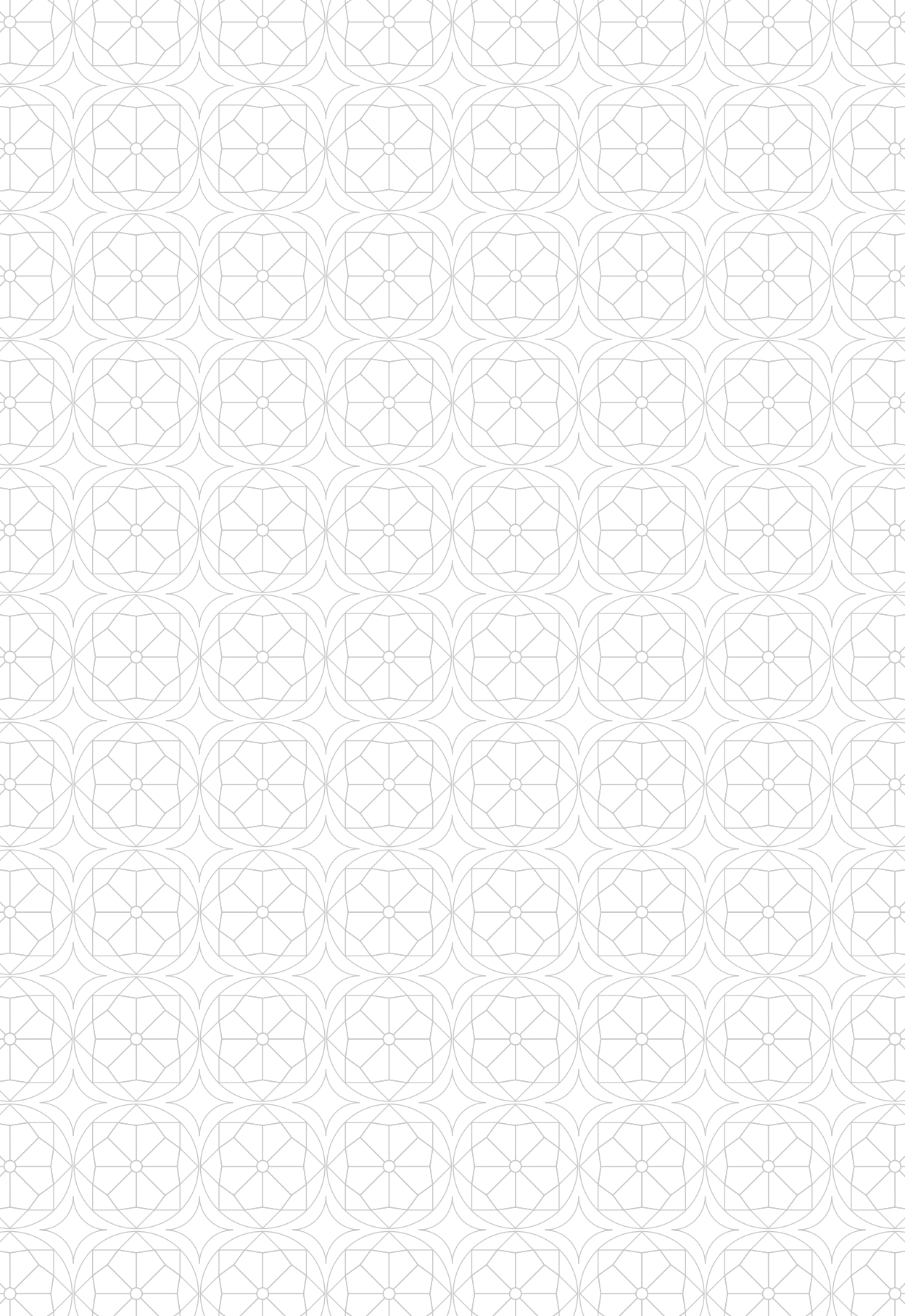
