### Chairman of the Executive Council Resolution No. (38) of 2019 Concerning the Appointment of the Chairman of Abu Dhabi Early Childhood Authority

### We, Mohamed bin Zayed Al Nahyan, Crown Prince, Chairman of the Executive Council,

Having reviewed:

- Law No. (1) of 1974 concerning the Reorganisation of the Governmental Body in the Emirate of Abu Dhabi and its amendments;
- Law No. (21) of 2019 concerning the establishment of Abu Dhabi Early Childhood Authority; and
- Based on what was presented to and approved by the Executive Council; Issued the following Resolution:

### Article (1)

H.H. Sheikh Thiab bin Mohamed bin Zayed Al Nahyan shall be appointed as Chairman of Abu Dhabi Early Childhood Authority.

### Article (2)

This Resolution shall be effective from the date of its issuance and published in the Official Gazette.

### Circular No. (5) of 2019 Concerning the Agreements and Memoranda of Understanding with Foreign Entities

### To all governmental entities in the Emirate of Abu Dhabi

Peace and Allah's mercy and blessings be upon you,

We are pleased to greet you and to extend our sincere gratitude for your continuous cooperation to realise the common interest.

- In the framework of developing the procedures of concluding agreements and memoranda of understanding with foreign entities, and based on the controls approved by the Executive Committee, we kindly urge you to commit to the following:
- 1. The governmental entity shall have the necessary financial allocations within its approved budget in case of the conclusion of any agreements which entail financial obligations.
- 2. Coordinate with the local entities concerned with the subject of the agreement or the memorandum of understanding.
- 3. The governmental entity shall be in charge of preparing a legal study on the agreement or memorandum of understanding and verify the extent of its compliance with the applicable legislations in the State as well as the implications thereof.
- 4. The request shall be submitted to Abu Dhabi Executive Office including a copy of the agreement or memorandum of understanding as well as the legal study and the request of authorisation form adopted by the Ministry of Foreign Affairs and International Cooperation.
- 5. Abu Dhabi Executive Office shall be in charge, in case of approval, of sending the request with the necessary documents to the Ministry of Foreign Affairs and International Cooperation.

- 6. Abu Dhabi Executive Office shall reply to the entity whether by completing and carrying out the procedures or refraining therefrom through official correspondence.
- 7. In case the request is approved, the concerned governmental entity shall complete the procedures and sign the agreement or memorandum of understanding and provide Abu Dhabi Executive Office and the Ministry of Foreign Affairs and International Cooperation with a copy thereof.
- Circular No. (12) of 2014 concerning the agreements and memoranda of understanding with foreign entities shall be repealed.
