Article (1)

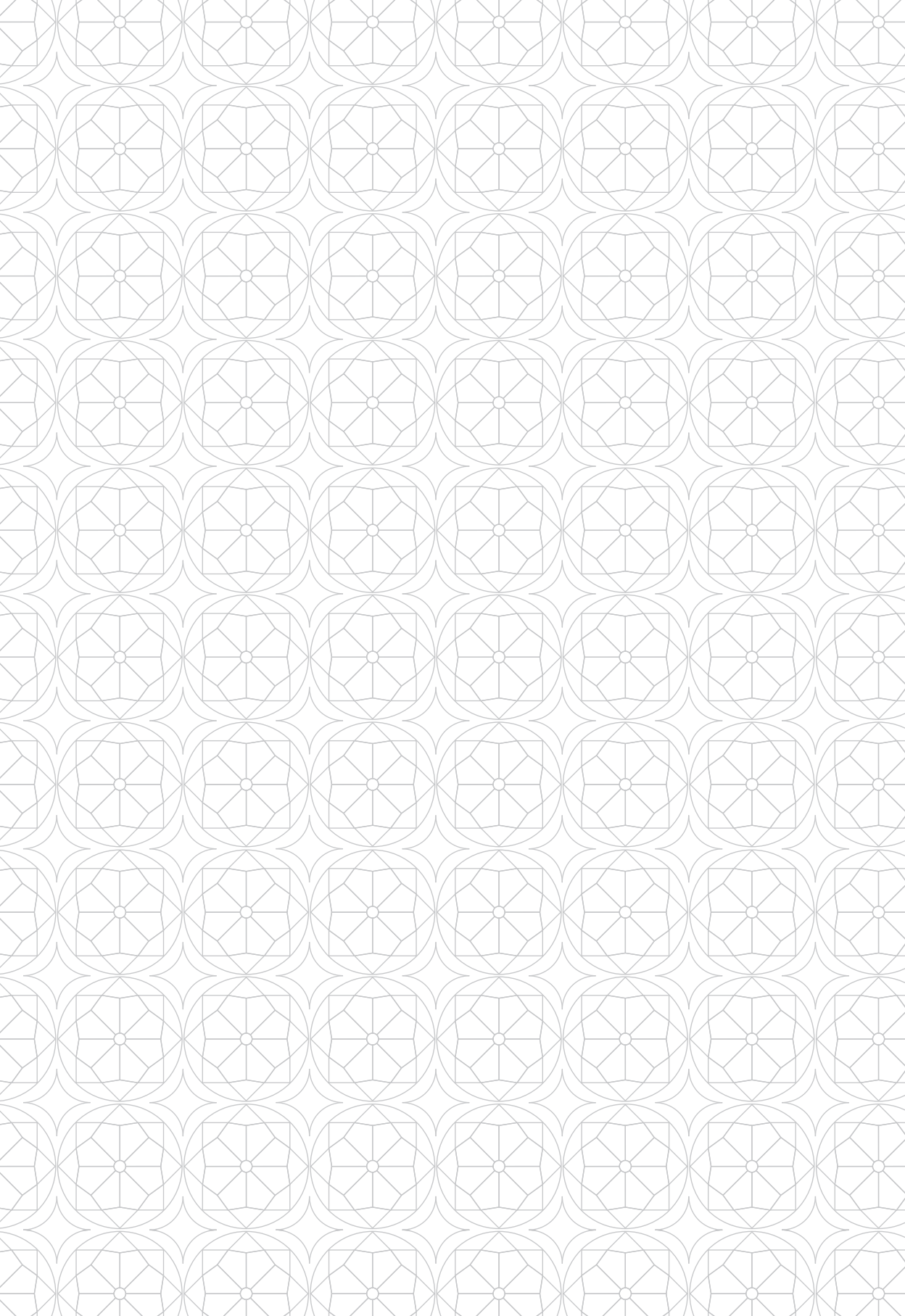
H.E. Saif Saeed Ghobash shall be appointed as Director-General of Abu Dhabi Executive Council.

This Resolution shall be effective from the date of its issuance and published in the Official Gazette.

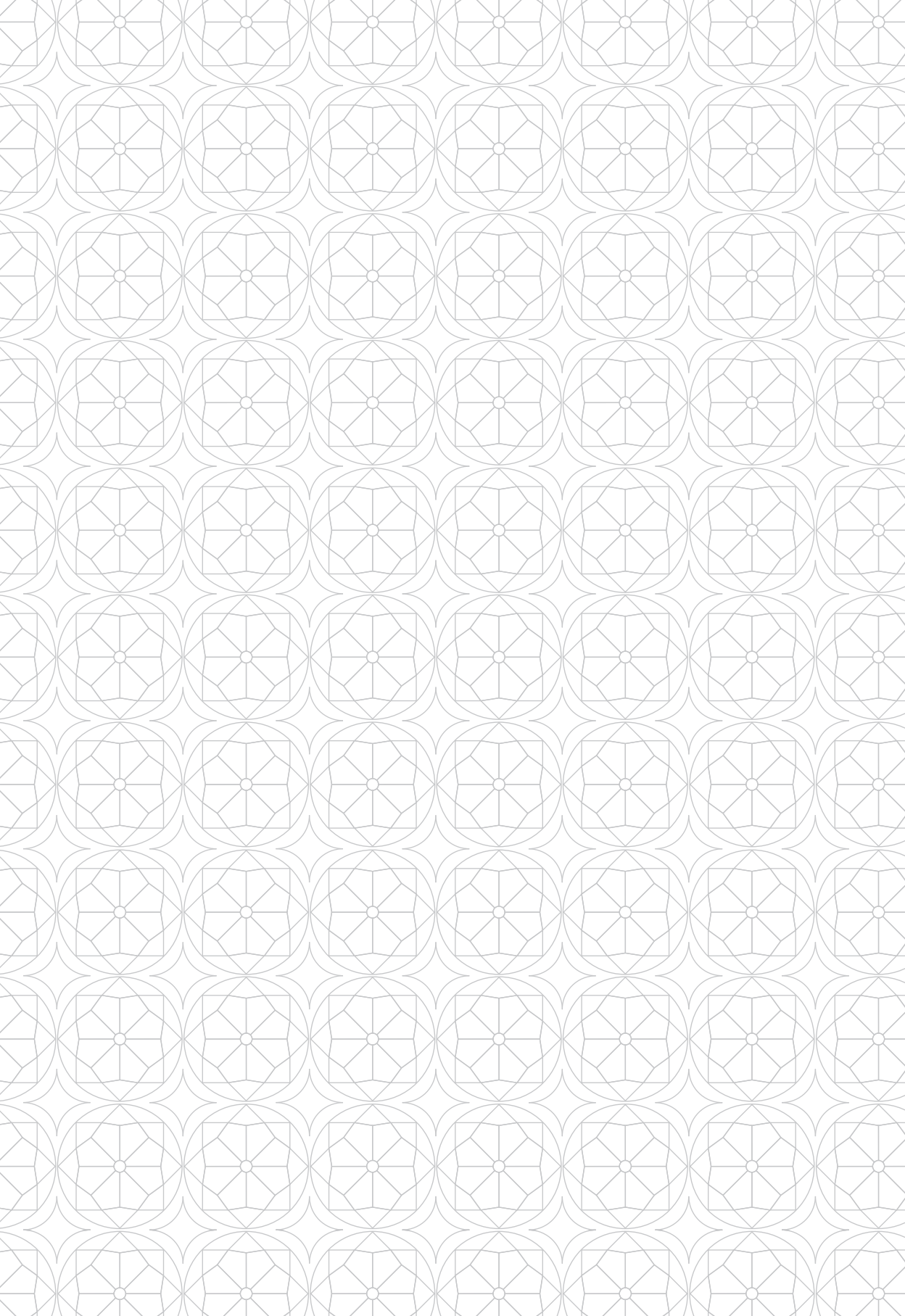

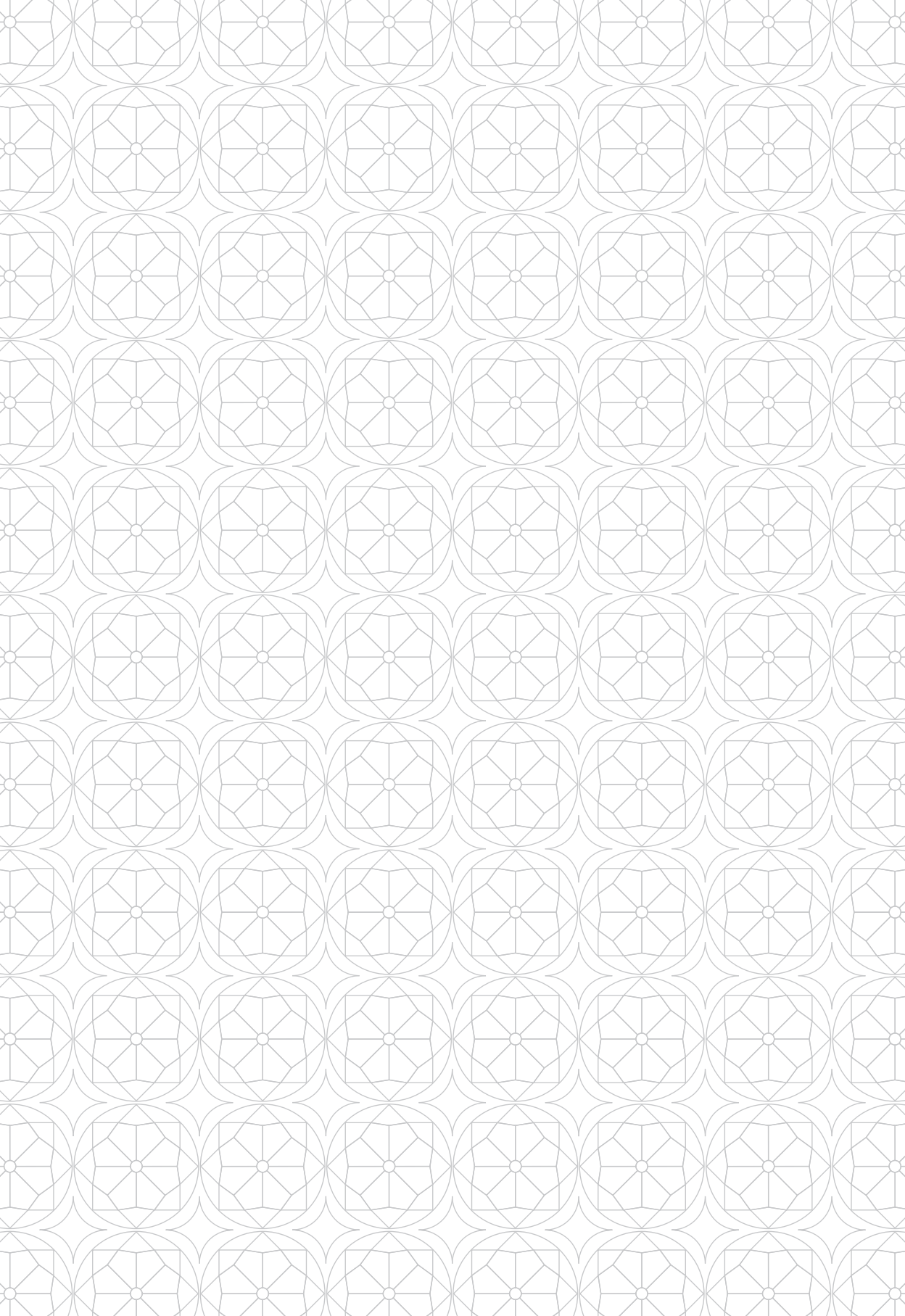
