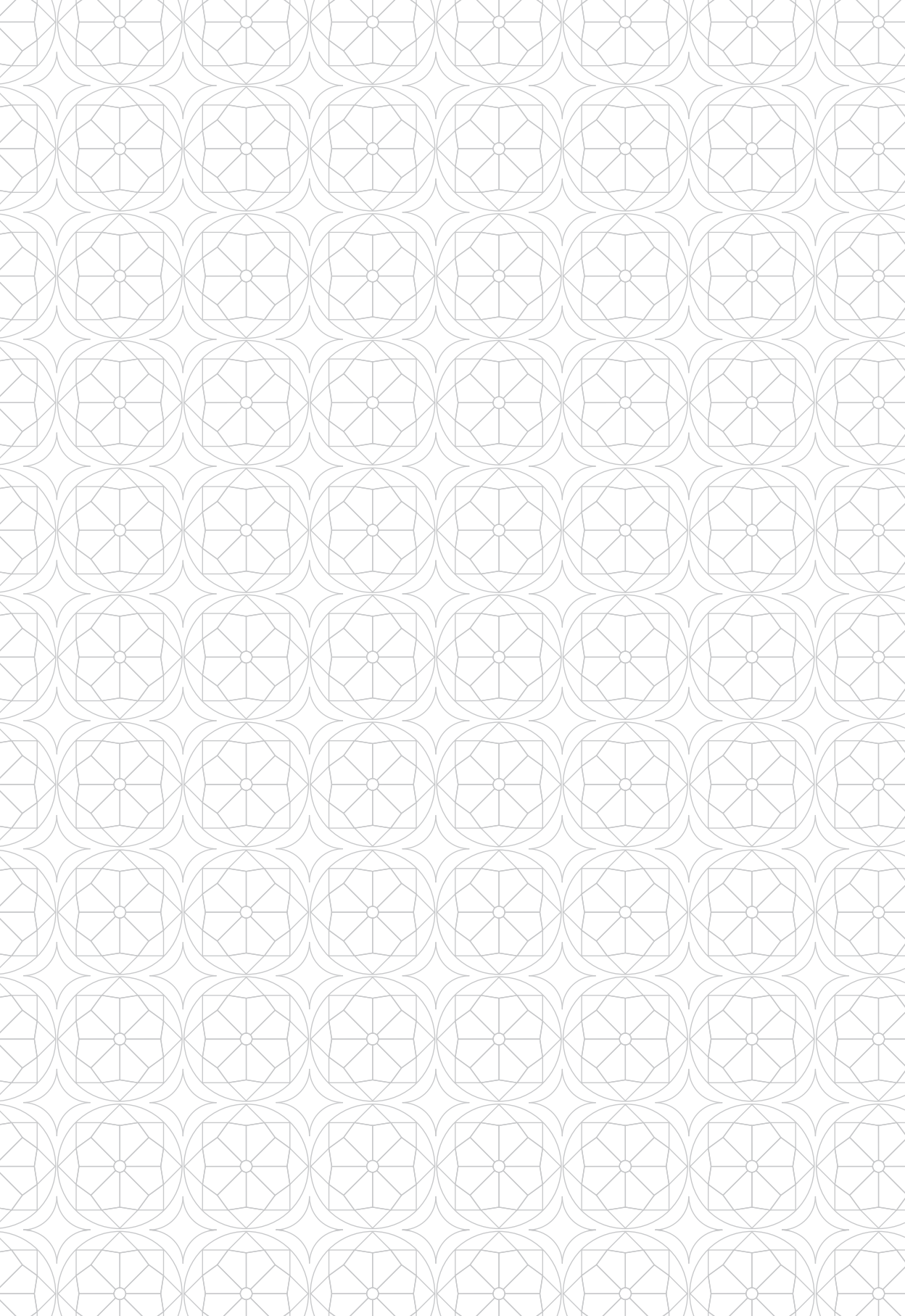

Article (1)

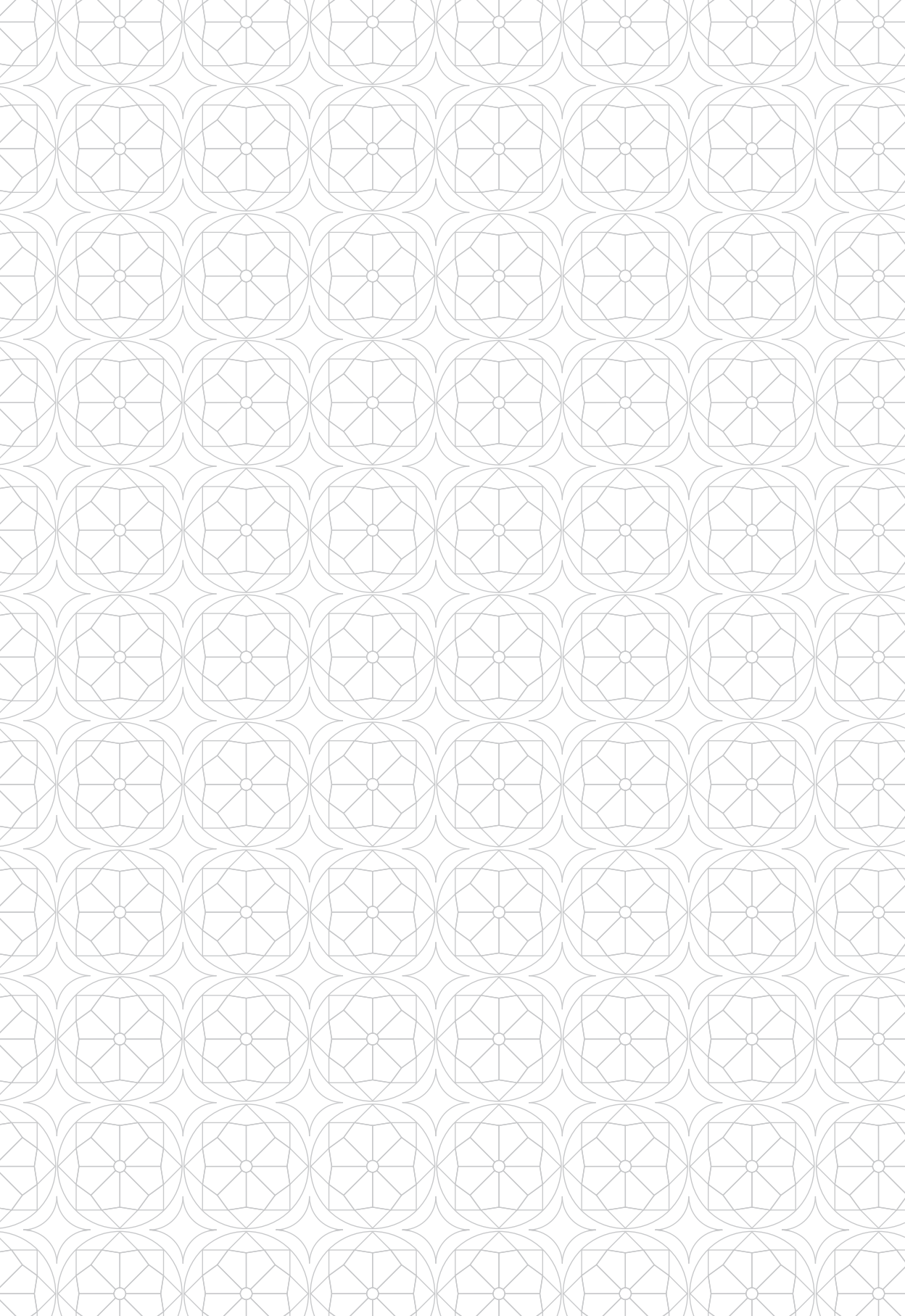

This Resolution shall be effective from the date of its issuance and published in the Official Gazette.

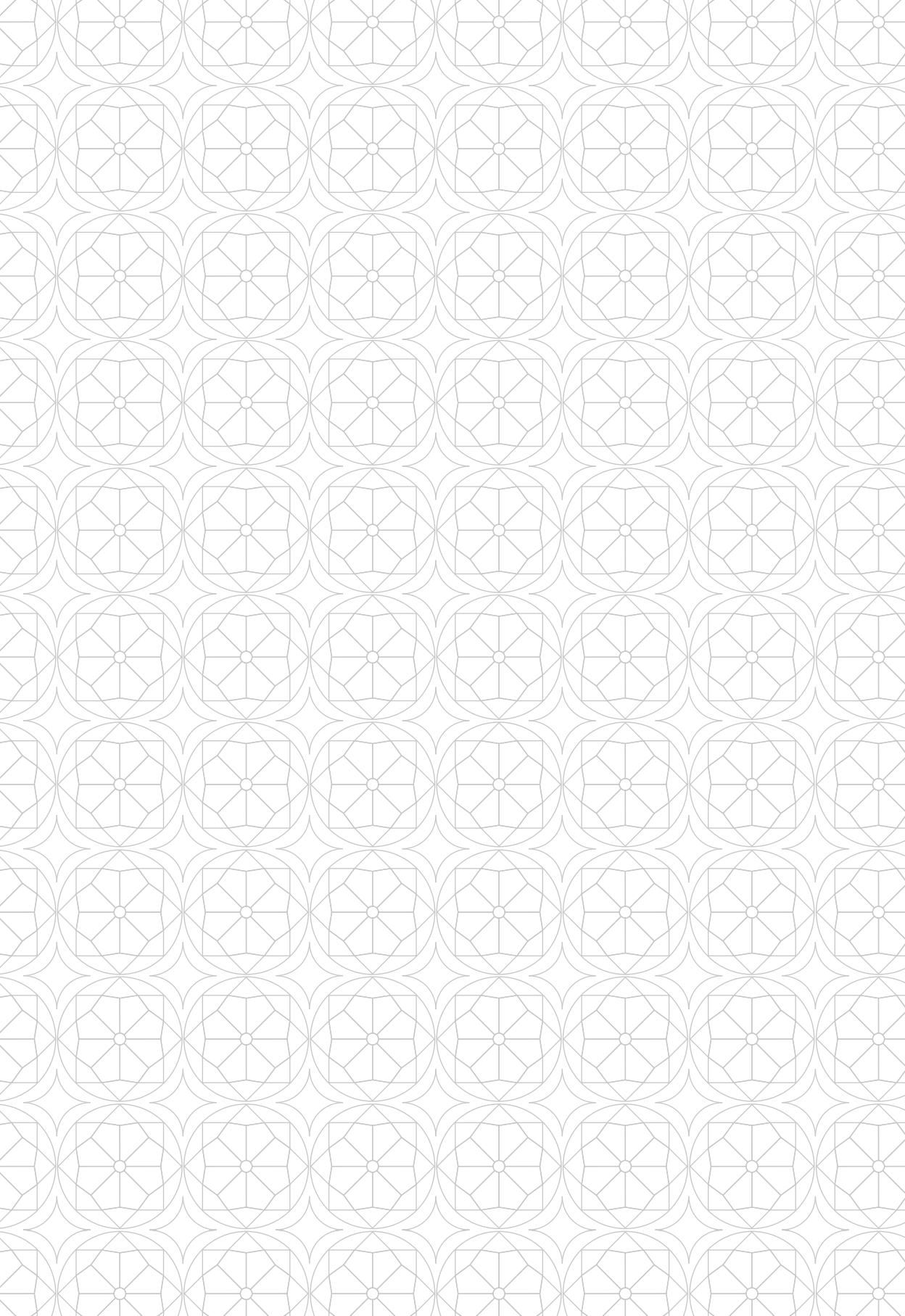

Executive Council Resolution  
No. (19) of 2022  
concerning Tourism Activities Licensing Fees

The Executive Council has decided the following:

1. Approve that licensing fees for alcoholic beverages, cultural licensing fees and holiday homes activity licensing fees shall be exempted from the provisions of Executive Council Resolution No. (106) of 2021 on Economic Licensing Fees.
2. Instruct the Department of Culture and Tourism to provide the Department of Finance with the revenues from the aforesaid fees in the previous Clause, in accordance with the applicable legislations and regulations.
